Re: Race Together Campaign

Dear Ms. Helm:

It is good to see a corporation that understands the importance of having a good environment in which a business can continue to grow with the community they serve.

I would ask you to seriously ask yourself the following questions:

Is it possible that the root of the problem that you wish to solve is not "racial" but rather it is a problem that grows from the fact that our government is corrupt?

Is the "racial problem" better today than it was when Barack Obama became president?

Is this the kind of "projects" that Starbucks defends?


