WE HAVE MORE THAN 500 STATE AND LOCAL LAW ENFORCEMENT PROFESSIONALS REGISTERED TO ATTEND.

EACH SHERIFF'S DEPARTMENT AND THE VAST MAJORITY OF OUR STATES POLICE DEPARTMENTS HAVE AT LEAST ONE REPRESENTATIVE IN ATTENDANCE.

STATE AGENCIES IN ATTENDANCE ARE DSS, DHEC, LLR, SC NATIONAL GUARD, SCANG AND DPS. THE FEDERAL AGENCIES ATTENDING ARE THE FBI AND THE US ATTORNEY GENERALS OFFICE.

THE TRAINING WILL HIGHLIGHT SLED's COMMITMENT TO SUPPORT LOCAL LAW ENFORCEMENT BY "SECURELY" SHARING ACCURATE AND TIMELY CRIMINAL JUSTICE INFORMATION TO HELP PROTECT OUR STATE.
