An emergency meeting of the Anderson County Council was held on September 25, 1989 at 9:00 a.m. in the Anderson County Council Chambers - Room 109. Chairman James M. "Jimmy" Cox, Jr. presided.

Chairman Cox called the meeting to order and Mr. David Watson gave the invocation. Everyone stood and pledged allegiance to the flag.

Chairman Cox explained that the reason for the emergency meeting was due to the destruction caused by Hurricane Hugo and to discuss some type assistance to the stricken areas. Council addressed the immediate needs of the people and what Anderson County can do as far as assembling goods and providing transportation. Mr. Watson explained that Florence County Emergency Preparedness had requested heavy equipment; front end loaders, dump trucks, generators. The County was in a position to send a front end loader, a low boy, two tandem dump trucks and three class three drivers. Council discussed the purchase of milk jugs for water. Mr. Randy Price with Freedom Freight, Mr. Billy Joe Durham, Mr. Mike Wood with WCI have already offered the use of tractor trailer trucks for the County to transport supplies. Mr. Cox moved that Council affirm actions already taken by the Administrator and the Assistant Administrator and to okay the moving forward with the effort with Anderson County's resources which are available. This includes Road Maintenance vehicles, equipment and personnel. Mr. Hooper seconded the motion and vote was unanimous.

Mr. Cox moved to authorize the Administrator to spend up to \$10,000 out of the Contingency Fund for emergency relief in whatever form, area necessary. Mr. Holden seconded the motion and vote was unanimous.


