In Memory of Trish Vradenburg

NASUAD is profoundly sad to share that Trish Vradenburg passed away on April 17. Trish founded UsAgainstAlzheimer's with her husband George Vradenburg. UsAgainstAlzheimer's was born out of their passion to fight back against Alzheimer's disease, which Trish's mother Bea Lerner, the wife of her father Joseph H. Lerner, succumbed to in 1992. Trish was instrumental in leading the organization on a path to make meaningful progress against a disease that caused her family so much pain.

Trish was a relentless advocate who helped achieve increased funding for Alzheimer's research and build a growing public-private consensus that a cure for the disease must be reached by the year 2025. Recently, she spearheaded the launch of the Alzheimer's Party, imploring members of Congress to join a bipartisan movement to end Alzheimer's disease.

There will be a public memorial service in Washington, D.C., on May 9 at a venue to be determined. Family and friends will be honoring Trish's legacy.

Male Caregivers Video Series

The AARP Public Policy Institute (PPI) has released a new video series that features male caregivers talking about their experiences. The videos include:

- a [millennial](#) caring for his wife and their young daughter,
- a [partner](#) sharing the challenges and triumphs of caring for a terminally ill partner,
- a traditional-style [support group](#) for African-American male family caregivers, and
- an [organization that supports](#) a group of male family caregivers of partners with a terminal illness.

There is also a new report from the AARP Public Policy Institute

that reports that the Caregiving in the U.S. 2015 survey found that 40% of family caregivers in the United States are men. The report [Breaking Stereotypes: Spotlight on Male Family Caregivers](#) describes who the male family caregivers are, the range of caregiving tasks they provide, and their experiences and challenges.

Women and Long-Term Services and Supports

More women than men will need long-term services and supports (LTSS) in their lifetimes due to longer than average life spans and higher rates of disability and chronic health problems.

Furthermore, women are also the primary providers of LTSS; women make up the majority of both paid direct care workers and unpaid family caregivers.

Grant Opportunities

ACL Grant: Small Business Innovation Research Program Phase II

The Federal Small Business Innovation Research Program's (SBIR) aim is to stimulate technological innovation in the private sector, strengthen the role of small business in meeting Federal research or research and development (R/R&D) needs, and improve the return on investment from Federally-funded research for economic and social benefits to the Nation. More specifically, the program aims to improve the lives of people with disabilities through R/R&D products generated by small businesses, and to increase the commercial application of National Institute on Disability, Independent Living, and Rehabilitation Research (NIDILRR)- supported research results and development products. Phase II is intended to expand upon the results of and to further pursue the development of Phase I projects.

Phase I grantees from fiscal year 2015 and 2016 are eligible to apply. Applicants must also continue to be small business concerns. An estimated four grants will be awarded to small businesses.

The closing date for applications is **Jun 12, 2017**.
