**Associated Press:** Ethics reform bills introduced in SC Senate

Measures to strengthen South Carolina's ethics laws have been introduced in the Senate. Sen. Wes Hayes says the three measures he introduced Wednesday serve as a starting point for the Senate Judiciary Committee. One would ask voters whether complaints against legislators should be handled by the state Ethics Commission. House and Senate panels would no longer investigate their own members.

**Note:** The measures come a week after an independent commission created by Gov. Nikki Haley issued 23 recommendations for overhauling ethics laws.

Hayes wants S.C. lawmakers to disclose all income sources

A state senator, widely considered that body's dean on ethics issues, introduced bills Wednesday to require legislators to disclose all their sources of income, force political committees to reveal their financial backers and stop lawmakers from policing themselves. Sen. Wes Hayes, R-York, former chairman of the Senate Ethics Committee, said recent scandals and low marks from watchdog groups create an environment for the Legislature to pass meaningful bills and "not just something to make people feel happy."

**Note:** Four different groups have examined ethics reforms, including a commission created by Gov. Nikki Haley, which released its recommendations last week. Some of Hayes proposals mimic the suggestions from the governor's group.

A bill filed Wednesday would provide 10 years of free identity-theft protection to more than 3 million South Carolina taxpayers whose personal information was stolen in last year's cyber attack against the state Department of Revenue. The South Carolina Senate measure also calls for creating a cabinet-level position that would be responsible for overseeing cyber security for all state agencies.

**Note:** Gov. Nikki Haley appreciates the support that legislative leaders have shown "as we work to make the people of South Carolina more secure," her spokesman, Rob Godfrey, said Wednesday. In her State of the State address last month, Haley told members of the General Assembly that the revenue department has taken numerous steps to foil future cyber attacks. These steps include encrypting data, creating a more complex identification process for the agency's employees and segmenting sensitive information.

The "sequester" portion of the August 2011 law that raised the nation's debt limit imposes automatic spending cuts of \$1.2 trillion over 10 years — half from defense programs and half from non-defense programs — unless Congress and the White House agree on a less drastic deficit-reduction plan.

Some changes may soon be coming to the food stamps program. State leaders are asking the federal government to make changes to the list on what's acceptable to buy on the program.
