My name is Stephanie and I am contacting you today in regards to my pregnancy Medicaid application. I applied back early December and received a letter telling me what all needed to be turned in to finish

processing my application. I turned in all the paperwork they asked me for, plus proof of pregnancy letter from my obgyn. I turned the paperwork in the last week of December. I have yet to hear anything. I have called the Anderson Dss office I don't know how many times to ask about it and you can never get through to anyone. I will be 14wks pregnant this Sunday. Starting January 30th if I don't make \$500.00 payments to my obgyn office I will not be able to be seen for my checkups. I can not afford this because that is my house payment and we have three other children we provide for. I really need to get my pregnancy Medicaid approved as soon as possible, so I don't have to miss any obgyn appointments. All I am asking is to know what is going on with my application.
