- 5) A list of all fees requested by the Office of the Governor related to the aforementioned requests.
- 6) A list of all fees received by the Office of the Governor in connection to the aforementioned requests.
- 7) A list of the state government employees who have searched for, reviewed, or processed Freedom of Information Act requested records for the Office of the Governor during aforementioned timeframe.
- 8) A list of government salaries for any state employees referenced above.
