2. The Innovations Award second round application must be completed by advancing programs via our application website: <http://www.innovationsaward.harvard.edu/> . The attached 2012 Supplemental Application Tutorial is a guide to the online application.
3. Please submit your completed Supplementary Application via our online application website by 3:00 PM EST on

Tuesday, August 14th, 2012.

4. Using the "Agency Director Signature Page" (attached), obtain the signature, which symbolizes the endorsement of the application, from the director of your agency. This is the most senior person responsible for the day-to-day management of the program, such as the director of a state agency, the principal of a school, the undersecretary of a federal department.

Please print a copy of your completed Supplementary Application for your agency director so they can read the completed application before signing the Agency Director Signature Page. Send the completed Agency Director Signature Page, so that it arrives in our office by 3:00 PM EST on Thursday, August 16th, 2012.

5. Read the "CEO Endorsement Explanation" sheet (attached) and make contact with the office of your CEO in order to expedite the process of obtaining the CEO's signature. Please complete the CEO Signature Page (attached) and mail the original signed document so that it is received in our office by 3:00 PM EST on Thursday, September 6, 2012.

6. The second round of the Innovations Awards competition will conclude in late fall 2012, when Innovations Awards evaluators will identify the "Top 25" programs in this year's competition, and each of those programs will receive extensive press coverage. Please refrain from making any public announcement regarding your program's status until that date.

The Innovations Award Program is eager to learn more about your valuable initiative. If for some reason you decline to continue participating in the 2012 Innovations competition, please inform us of your decision as soon as possible.
