Tyrena,

Am I reading this email correctly in interpreting that anyone who accompanies the Governor to her speaking engagement (ex. her Husband, security officials, public relations manager, assistant, and commerce attendant) must register and pay a fee to come in the door? For every past conference that we've



attended, it has been customary for staffers to accompany a speaker without having to pay an entrance fee. These people would attend no other portion of the conference besides the governor's speaking event. Please clarify when you're able! Obviously, it would not be good for them to be denied entrance due to not having a name badge, so this will need resolved asap.

Also, we are still lacking a lot of detail on the Tech Summit. I need the following questions answered as soon as possible:

- When we arrive at the Expo Centre, where should we go?
- Will someone be there to greet us upon arrival? If so, who is this person and can we get a contact name/phone number/email?
- Is there a holding room available and will it be a private or shared space? If shared, who will be in attendance?
- Layout of the stage, seating arrangement of panelists
- Microphone – will there be stationary microphones in front of the seats, or handheld microphones?
- Format and program – will the governor be expected to speak for a certain period of time? Will it just be Q&A? I need a run of show as soon as possible, along with the questions that she'd be expected to answer.
- Reserved seating – We will need reserved seating for the First Gentleman, Public Relations Manager, Assistant, Cultural Agent, and Ford. Please confirm location and ability to reserve.
- Will there be press at the event and will she be expected to address the press in any capacity? Can you provide a list of media attending? She currently plans to depart immediately upon conclusion of the event.

Apologies for all of the questions, the governor's office requires very thorough briefings.
