New Carolina got \$650,000 in FY 2013-14 and Commerce (eventually) asked for \$400,000 in FY 2014-15. Not a vote of confidence. Certainly not a request for another \$100,000 above and beyond the \$650,000.

The Executive Budget recommended \$0, based in substantial part on the fact that – at the time – Commerce wasn't requesting anything for New Carolina at all. You see, that link doesn't take you to what the Department of Commerce originally requested. The link takes you to an undated revision that they submitted sometime later (I'd have to call the Budget Office to find out when).

We wrote the budget based upon the request we had from Commerce at the time (the one on my desk is dated October 22nd) that requested nothing for New Carolina. Whenever the revised submission was filed, nobody sent it to me, and nobody asked us to make any changes accordingly.
