### State Medicaid Integration Tracker: December 2016 Edition

NASUAD has published the [December Edition of the State Medicaid Integration Tracker](#). The State Medicaid Integration Tracker is a monthly report summarizing state actions in Managed Long Term Services and Supports (MLTSS), as well as State Demonstrations to Integrate Care for Dual Eligible Individuals and other Medicare-Medicaid Coordination Initiatives. The Tracker also includes updates on state participation in other LTSS activities, including: the Balancing Incentive Program; Medicaid State Plan Amendments under §1915(i); Community First Choice Option under §1915(k); and Medicaid Health Homes. This tracker includes new updates for each state that occurred during the most recent month.

### Webinar: Medicaid Managed Care for Long-Term Care Ombudsman

In Medicaid, managed care is a form of health care delivery and financing that aims to better manage cost, coordinate care, and improve quality. Managed care involves contracts between state Medicaid agencies and private managed care organizations, or MCOs, that are responsible for the delivery and coordination of services to beneficiaries. MCOs receive a capitated per-member per-month (PMPM) payment to cover the costs of these health care services. Over the past decade, state agencies have implemented managed care in increasing numbers, with total U.S. enrollment in Medicaid managed care reaching 55 million in 2014.

A significant amount of the recent managed care growth has focused on including long-term services and supports (LTSS). The rapid expansion of Managed LTSS has implications regarding the health care and social services provided to older adults and people with disabilities living in institutional settings and other LTSS facilities such as assisted living.

This webinar will cover basic information about the current status and future directions of state Medicaid Managed LTSS programs; key policy and operational considerations for professionals working with older adults enrolled in these programs; and future directions for these programs. ## Medicaid & CHIP: September 2016 Report

The Centers for Medicare & Medicaid Services (CMS) released their monthly report for September 2016 on Medicaid and CHIP application, eligibility determination, and enrollment data. States provide data to CMS on factors related to key application, eligibility, and enrollment processes using the Medicaid and CHIP Performance Indicator Project. The data is then used to inform CMS on the operations of the programs in each state and to share state performance data publicly.

## Centers for Medicare & Medicaid Services

### CMS Releases FAQs Regarding Unsafe Wandering or Exit-Seeking Behavior

On December 15, 2016, CMS released a set of FAQs that discuss strategies that are compliant with the HCBS Settings regulation and can be used to ensure the health and welfare of HCBS participants who are at risk of wandering. The long-awaited FAQs focus primarily on how person-centered planning should be used to identify appropriate restrictions while facilitating individualized activities, supports, and access to the community.

CMS reiterates the person-centered planning issues throughout the entire document. Other areas of emphasis include adequate staffing to allow for various activities in and outside HCBS settings, proper staff training to identify issues and promote person-centered responses, and the establishment of programs and environments that engage participants, reduce overstimulation, and promote overall beneficiary wellness.

The FAQs address a number of important policy and operational considerations that HCBS providers should address when providing services to individuals with wandering behaviors or who are at risk of wandering.

## **CMS Issues Memorandum Regarding Long-Term Care Facilities**

On December 9, 2016, the Centers for Medicare & Medicaid Services (CMS) issued a memorandum regarding the enforcement of the pre-dispute binding arbitration agreement prohibition contained in the recent final rule Reform of Requirements for Long-Term Care Facilities, which became effective November 28, 2016. On November 7, 2016, a U.S. District Court issued an order prohibiting enforcement of section 483.70(n)(1), which contains the provision banning pre-dispute arbitration agreement for long-term facilities receiving Medicare or Medicaid funds. In the December memorandum, CMS states that they will not enforcement section 483.70(n)(1) "until and unless the injunction is lifted."

## **CMS Releases MBES VIII Group Enrollment and Expenditure Data**

On December 15, 2016, the Centers for Medicare & Medicaid Services (CMS) released updated Medicaid enrollment data and preliminary expenditure data that states reported to CMS through the Medicaid Budget and Expenditure System (MBES). The [enrollment information](#) is a state-reported count of unduplicated individuals enrolled in the state's Medicaid program at any time during each month in the quarterly reporting period and includes new enrollment data from January 1, 2016 - March 31, 2016. The preliminary [expenditure data](#) provides summary level data associated with Medicaid service expenditures reported by states on the Form CMS-64 in MBES for the period July 1, 2015 - September 30, 2015.

On December 13, 2016, the Centers for Medicare & Medicaid Services (CMS) released an information bulletin to the states and other stakeholders regarding personal care services (PCS). The bulletin "describes PCS, summarizes the program integrity vulnerabilities, and highlights safeguards state Medicaid agencies can put in place to strengthen program integrity in PCS without undermining beneficiary access to PCS, especially self-directed services."

The AARP Foundation and IMPAQ International published a resource guide and toolkit regarding the implementation of food security screening and referral for older adults. ## State Insights on Refining Integrated Care for Dually Eligible Beneficiaries

The Center for Health Care Strategies (CHCS) recently released a brief called *State Insights on Refining Integrated Care for Dually Eligible Beneficiaries*, which highlights perspectives on the 14 states participating in CHCS' Implementing New Systems of Integration for Dually Eligible Enrollees (INSIDE) project. The report notes five key program improvements for states looking to enhance their care integration models: modifying care management models and requirements; improving beneficiary understanding of coordinated care; developing strategies to increase enrollment; enhancing administrative alignment between Medicare and Medicaid, and; supporting health plan sustainability.

## National Association of State Budget Officers

### Fall 2016 Fiscal Survey of States

On December 13, 2016, the National Association of State Budget Officers (NASBO) released the *Fall 2016 Fiscal Survey of States*. NASBO gathered data from all 50 states to use for this semi-annual report. States' enacted budgets for fiscal 2017 (the current fiscal year) project moderate general fund spending growth for the seventh consecutive year. However, progress since the Great Recession has been uneven, and many states are seeing softening state tax collections.
