Dear Governor Sanford,



My child, Gillen Adam Velkovich, currently receives physical therapy at Touchstone Therapy in Pineville, NC. We are fortunate to have a pediatric clinic to take my child to so he is able to receive this therapy because there are not many providers available who accept South Carolina Medicaid.

However, due to the low reimbursement rates, Touchstone Therapy may no longer be able to continue providing my child with this necessary therapy. The South Carolina Medicaid rate is half of the reimbursable rate from North Carolina Medicaid. This makes it difficult for a therapy provider to cover their costs and continue to provide exceptional care to my child.

Unless the South Carolina Medicaid rates for occupational, physical and speech therapy are increased within the next 90 days, Touchstone Therapy will have no choice but to discontinue their provider status with South Carolina Medicaid. If Touchstone Therapy is no longer a provider for South Carolina Medicaid, I will have no where to take my child for therapy.

I need your assistance in facilitating a *rapid* change in the reimbursement rate for pediatric therapy services by South Carolina Medicaid. If this does not happen, my child will risk losing the progress he has made and it will limit his ability to make further gains. This will not only affect him and other children with special needs, but the rest of our country's population as these children who may become contributable taxpaying members of society as a result of receiving these necessary therapies now, will instead become a financial burden to taxpayers and the economy as a whole.

Please act *now* to help my child as well as other families in South Carolina who have a child with special needs. I appreciate your immediate attention to and action on this matter.
