SECTION 1: The Minutes for the meeting of July 1, 1998; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion authorizing the Department to advertise and select consultant(s) to provide geotechnical services on an "on call" basis, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to advertise, select and negotiate with consulting firms to provide engineering services to perform studies and prepare right-of-way and construction plans for the renovation of rest areas and welcome centers statewide, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending an existing contract beyond the contract limits, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in extending an existing bituminous retreatment contract to include additional resurfacing work, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in rescinding its action in adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion adding sections of roads to the State Highway System, shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to advertise to secure services of one or more qualified and experienced proposer(s) who will serve as the overall project manager for multiple simultaneous transportation projects which comprises the Department's \$3 billion plus 10-year construction program, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion approving the projects included in the Pee Dee and Waccamaw Councils of Governments Project Acceleration Programs, as shown in detail in the Appendix.

SECTION 11: On motion of Commissioner Hardee, seconded by Commissioner Truluck, the Commission unanimously passed a motion to defer, for thirty days, action on a request by Representative Jennings McAbee relative to a 6.2 mile section of road that provides access into Savannah Lakes Village.

SECTION 12: On motion of Commissioner Hardee, seconded by Commissioner Truluck, the Commission unanimously passed a motion approving a request by Representative Roland Smith to install a traffic light at the entrance to Kimberly-Clark Corporation in Aiken County. Kimberly-Clark will pay the costs of this traffic signal.

SECTION 13: Commissioner Truluck made the following motion:

"I move that the Commission approve Florence County's request for the South Carolina Department of Transportation to participate in a fifty percent (50%) match program of the costs of Type B and Type C projects provided that the projects are in the State Highway System, that all federal funding eligibility requirements are met, that the contribution by the South Carolina Department of Transportation does not exceed \$13,400,000 (thirteen million, four hundred thousand dollars) in any one year and that the total amount contributed by the South Carolina Department of Transportation for

Type B and Type C projects does not exceed \$112,750,000 (one hundred twelve million, seven hundred fifty thousand dollars) and that the South Carolina Department of Transportation staff work with the staff of Florence County to work out mutually accepted participation agreements and to establish procedures and responsibilities for the handling of bidding and project management."

Motion was seconded by Commissioner Hardee and passed unanimously.

SECTION 14: There being no further business to come before the Commission, the meeting was adjourned at 11:05 a.m.

**"ON CALL" GEOTECHNICAL CONSULTANT(S)**

South Carolina Department of Transportation (SCDOT) requests Commission approval to advertise and select consultant(s) to provide geotechnical services on an "on call" basis. The contract will be for a period not to exceed three (3) years. Services will be provided for statewide projects. The funding source will be both State and Federal. The cost estimate for this work will be done on a project-by-project basis through negotiations with the selected consultant(s) with costs being provided to the Commission through the Executive Summary.

**"ON CALL" ENGINEERING SERVICES FOR STATEWIDE  
RENOVATION OF REST AREAS AND WELCOME CENTERS**

The Department requests Commission approval to advertise, select and negotiate with consulting firms to provide engineering services to perform studies and prepare right-of-way and construction plans for the renovation of rest areas and welcome centers statewide.

At present, the Department does not have sufficient staff and expertise to prepare building and roadway plans without curtailing progress on other high priority projects for which commitments have been made. Therefore, consultant services will be needed.

The current three year "on call" contract will expire December 31, 1998. The new contract will extend for three years. The Department will initiate work on individual rest area and welcome center sites in order to utilize available funds. The Commission will be notified as to the scope and cost of each project as funds become available.

EXTENSION OF CONSTRUCTION CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work, as follows:

**ABBEVILLE COUNTY:**

Contract of Sloan Construction Company, Inc. - File No.1.529 - extended to include resurfacing (File No. 1.10981) with asphalt concrete surfacing and necessary pavement markings on S-61 and S-44 for 3.48 miles.

Estimated Cost of Extension \$149,118.35

**GREENVILLE COUNTY:**

Contract of Eagle Construction Company, Inc. - File 23.001L - extended to include an additional section of Project C-423A (File No. 23.423A) consisting of intersection improvements at Shady Lane and Fisher Drive.

Estimated Cost of Extension \$ 29,033.24

**GREENWOOD COUNTY:**

Contract of Satterfield Construction Company, Inc. - File No. 24.670 - extended to include an additional section of Project SP C-670 (File No. 24.670) consisting of the resurfacing with asphalt concrete surfacing on S-600, S-601, S-602, S-603, S-604, S-605, S-606, and S-639 for a total of 1.833 miles.

Estimated Cost of Extension \$ 79,918.86

**KERSHAW COUNTY:**

Contract of United Contractors, Inc. - File No. 28.750 - extended to include an additional section of Project C-707 (File No. 28.707) consisting of the installation of steel beam guardrail and end anchors on SC 346 over Red Oak Camp Creek.

Estimated Cost of Extension \$ 21,993.03

**PICKENS COUNTY:**

Contract of Vulcan Materials Company & Subs Co. - File No. 39.57971 - extended to include an additional section of Project C-752 (File No. 39.752) consisting of the drainage and thermoplastic pavement markings to provide adequate drainage on 1,480 feet on SC 8.

Estimated Cost of Extension \$ 57,259.47

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

EXTENSION OF A CONTRACT BEYOND CONTRACT LIMITS

It is recommended the Commission approve the extension of the following contract beyond the contract limit as follows:

**MARION COUNTY:**

Contract of APAC-Carolina Inc. - File No. 34.552 - extended to include an additional section of Project C-584 (File No. 17.584) consisting of the resurfacing with asphalt concrete surfacing and pavement markings on US 501 Bypass for 2.51 km.

869 4 Section of road adjacent to Summerville from S-184 (North Gum Street) southeasterly to S-868 – approximately 0.14 mile Designated S-251 Note: This addition is recommended since it was constructed by File 18.554 without first being added to the State Highway Secondary System.
