M I N U T E S

A REGULAR MEETING OF THE ANDERSON COUNTY COUNCIL WAS HELD ON MAY 7, 1985 AT 9:00 A.M. IN THE COUNCIL CHAMBERS - ROOM 109. CHAIRMAN DAN RHODES PRESIDED.

Mr. Rhodes called the meeting to order and Mr. Watson gave the invocation. Everyone stood and pledged allegiance to the flag.

Mr. Cox moved that the April 2 minutes be amended. The amendment would be on page 3 under amendment #3 (middle of page) change "Dalrymple" to "Shackleburg" Road. The amendment was seconded by Mr. Hooper. Vote was unanimous. The clerk has made the correction.

On the motion of Mr. Rhodes, seconded by Mr. Cox, Council voted unanimously to approve the April 16 and May 1, 1985 minutes as mailed.

Mr. Doug Phillips, Executive Director of the Appalachian Council of Governments, presented Council with a performance report for an 18 month period ending December 31, 1984. Council received as information.

Ms. Annette Buchanan asked Council to support efforts to have the state install seat belts in all school buses. On the motion of Mr. Rhodes, seconded by Mr. Cox, Council voted unanimously to send a resolution to the Anderson County Delegation supporting the use of seat belts in school buses.

Mr. Harold Beebe nominated Mr. Harry S. Thompson for reappointment to the Recreation Commission. Mr. Cox nominated Mr. Bill Hopkins, Mr. Wiles nominated Mr. Blair Rice, Jr. for reappointment and Mr. Rhodes nominated Mr. Jerry Floyd for reappointment. All other appointments were deferred until the next meeting. Vote was unanimous on all nominations.

Mr. Harold Beebe nominated Mr. Frank Hooper, Mr. William Hood and Mr. Sam O. Sullivan, Jr. for reappointment to the Alcohol and Drug Abuse Commission. Vote was unanimous.

Mr. Wiles presented Resolution #274 whereby the County request the support of the Legislative Delegation to provide for the improvement and operation of the Army Corps

of Engineer's Highway 181 operational boat ramp. He then moved that the Resolution be approved. Mr. Beebe seconded. Vote was unanimous.

Mr. Rhodes presented an amendment to ordinance # 70 (creation of the M-R Board) for Council's consideration on first reading. The amendment would be to change paragraph #2 to read as follows: "'Of the seven members, no more than three shall be parents or guardians of a developmentally disabled child. No more than two shall be voluntary representatives of agencies or service organizations pertaining to the developmentally disabled.'" He then moved that Council give first reading approval to this ordinance (#170). Mr. Cox seconded the motion. Vote was unanimous.

Mr. Hooper presented Resolution #275 to change the name of the Anderson County Stockade to the Anderson County Corrections Facility. He then moved that the resolution be adopted. Mr. Beebe seconded the motion. Vote was unanimous.

Mr. Mullinax asked that Ordinance #168 (Civic Center) be deferred until later. Council agreed.

Mr. Mullinax presented first reading of Ordinance #169 prescribing the rates and regulations for the sewer system operated by the Anderson County Sewer Authority for Anderson County. Mr. Wiles moved that the ordinance be approved on first reading. Mr. Hooper seconded. Vote was unanimous.

Council heard a request from the Fred Tiller Company to collect back unemployment taxes from county employers. He is presently collecting delinquent unemployment taxes in Greenville County. Council received as information.

Council discussed the purchase of the old church rectory on McDuffie Street for Planning & Development Board office space for \$125,000. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to approve a resolution to purchase the building. (see resolution #277.)

Mr. Mullinax informed Council that the County stands a good chance to receive the Veterans Nursing facility.

Mr. Hooper suggested that the Building Codes Department check on warranties passed on to buyers from the builders.

Mr. Watson presented the road maintenance activity report for Council's information.

Mr. Hooper asked that the Administrator check into numbering all trucks at the County Stockade.

Mr. Watson presented Council with a budget report for the first three quarters of the budget year for information only.

Mr. Watson briefly discussed the Governor's Criminal Justice Plan with Council.

Mr. Burns asked for permission to purchase building materials for bridges from the only bidder for \$12,742.80. The only bid was from Kaiser Aluminum. Mr. Hooper moved that the Council allow the purchase. Mr. Rhodes seconded. Vote was unanimous.
