Dear Sheriff Taylor:

An extradition hearing regarding the above-captioned matter was conducted by the South Carolina Attorney General's Office on September 19, 2003, at 10:30 AM. Mr. Richardson was present for the hearing.

The Attorney General's Hearing Officer, C. Havird Jones, Jr., Esq., has reviewed the papers submitted by Virginia in support of their request for extradition of Rancy L. Richardson. Chief Probation and Parole Officer, Kelly D. Ashley, was contacted in Virginia as to Mr. Richardson's statement that his probation officer had told him he did not need to see him any longer and he could return to South Carolina. Officer Kelly advised that Mr. Richardson had not been told by his probation officer that he did not need to see him any more. Officer Kelly further stressed that Mr. Richardson needs to appear before a judge in Virginia in order to resolve this matter. The recommendation has been made, and Governor Sanford has concurred, to honor the extradition request of the State of Virginia for the return of Rancy L. Richardson.

Accordingly, enclosed are an original and one copy of Governor Sanford's rendition warrant and the agent's commission from the **State of Virginia** which authorizes you to deliver the subject to the agent(s) named therein. Please notify **Linda D. Curtis, Commonwealth's Attorney, 236 North King Street, Hampton, Virginia 23669, Tel. No. 757-727-6442, Fax No. 757-727-6802**, when the subject is available for release after final disposition of any pending South Carolina charges. Please inform our office when **Rancy L. Richardson** has been returned to **Virginia** so that we may close our files accordingly.
