Mr. Poore called the meeting to order and Councilman Curtis Kinley gave the invocation.

On the motion of Mr. Wright, seconded by Mr. Kinley, Council voted unanimously to approve the minutes from the December 15, 1981 meeting as mailed.

On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to approve second reading of Ordinance #76. This ordinance would amend the 1981-82 budget for the Sheriff's department to include \$4,107.50 from the sale of confiscated goods into code 79 (direct assistance).

Mr. Thad Arnold asked that Council approve a request by the Veterans Affairs officer to transfer from account #450.11 to code 65-\$519.00 to be used to install an emergency exit door for his office in the Bailes Building. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to approve the request.

Mr. Karl Kenyon presented third and final reading of ordinance #75 (Salaries). On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted 3 in favor and 2 opposed. (Mr. Bratcher and Mr. Wright opposed.) The Ordinance was amended to read salary would be \$8500 and expense \$1500 for Council members. Motion passed by majority vote. Mr. Poore stated he opposed the Ordinance.

Mr. David DeHoll spoke in favor of adopting Ordinance #75 (Transportation-Nuclear Material). Council also heard remarks from Dr. Robin Kelly and Ms. Larkin Mims; which were in favor of the Ordinance. Mr. Robert Olson (Westinghouse) spoke against the Ordinance. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt on second reading Ordinance #75.

Mr. Poore stated that \$3036.00 had been approved for Anderson County by the S.C. Wildlife and Game Commission. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to start work on the boat ramps on Brown Road and behind Shirley's store.
