





In 2007 Medicaid agreed to increase the reimbursement for corneal transplant tissue (V2785) to cover the cost of the tissue at that time. The Columbia Eye Surgery Center continues to provide this valuable service to patients in need of corneal transplants. The tissue is purchased from Lifepoint, Inc. and the costs have increased. The cost of the tissue is \$2,800 for whole globes and \$3,500 for pre-cut tissue for endothelial keratoplasties.

Corneal transplants are needed for many diseases of the cornea ranging from keratoconus to corneal edema (swelling). Transplants can restore vision to patients with these problems when there are no other alternatives. Historically, very few Medicaid patients need this service but we feel it should be available to all patients in need, regardless of their insurance coverage or inability to pay out of pocket.

Offering corneal transplants at our ambulatory surgery center is important for us to care for these patients. Our center has specialized equipment used to cut and prepare the tissue for transplant. Also, we have highly trained personnel that are required to set up and handle this equipment. I believe that we can provide state of the art care very efficiently for these patients.
