The following allotments were approved from the 1942-43 Civil Contingent Fund:

The State Auditor's Office, \$2,400.00 - for Assistant Auditors.

The Joint Committee on Printing, \$75.00, for Clerical Help.

The following allotment was approved from the 1941-42 Civil Contingent Fund:

The State Forestry Commission, \$1,855.50, for the erection of fire towers in Orangeburg, Lexington and Spartanburg Counties. One-half the cost of the erection of these towers is being borne by the counties.

A request by the Chief of the Emergency Medical Service of the South Carolina Council for National Defense for an allotment of \$4,975.00 from the Defense Contingent Fund, to cover the expense of his activities, was deferred until a subsequent meeting, and additional information was requested.

A request by the South Carolina Tax Commission for permission to use the sum of \$6,900.00 of the Beer and Wine Revenue, for the purpose of employing help and paying other expenses in connection with the enforcement of the Beer and Wine laws was granted. The Secretary was directed to advise the Commission to transfer, by warrant, this amount from the collections of the Beer and Wine tax to the Tax Commission appropriation accounts.

The Commission discussed a letter from Senator Burnet R. Maybank, concerning damage caused to roads in Lancaster County during the 1941 Army maneuvers, and of the effort that was being made by county officials to obtain settlement therefor. No action was taken by the Commission on this matter.

The Commission discussed a communication from Major Heyward Mahon, Director of the South Carolina Council for Defense, urging that the sum of at least \$60,000.00 be reserved in the Contingent Fund for National Defense, to be used in case of emergencies. The Communication was received as information.

The Commission discussed a communication from Mr. C. Norwood Hastie, President of Organized Business, Incorporated, relating to excessive transportation rates obtaining in South Carolina, and requesting the sum of \$30,000.00 for an investigation of same. The Secretary was directed to advise Mr. Hastie that, while the Commission was in sympathy with his position in this matter, it was without funds to provide for such an investigation.

The Commission then adjourned.
