Matthew Clark current ex dir of the Hardeville Chamber

Bill Miles not Charlie Clark his spokeswoman

Current Mayor of Hardeeville

Other town council members at that time

All past Chairmans of Hilton Head Chamber David Tigges , John Vann and anyone else .

We need to Talk to locals Ray Warco with Cherry Becket and Holland firm and Charlie Brown about the compensation committee they were on that approved Bill Miles Salary ?? Determine all and any

conflicts ?

We need to talk to the Chamber in house controller accountant Ray Deal in great detail. We need to talk to the company who did a third party audit hired by the Chamber that was not a true third party independent audit. We must do a third party audit regardless of victory in the SC Supreme Court. Members must demand this and board members must be forced to clean up all. We must separate the Cvb and Chamber , change bylaws , have elections for board members not appointed buddies with no term limits .

We need to understand all and any violations to the Chambers existing bylaws that have been violated like no annual meetings . We need to know who changed the Bylaws from the original bylaws ? We need to find out all info from Dale Augustine past ex dir who hired Bill Mikes on the original bylaws , elected board versus appointed with no term limits . How salaries and pay packages increased from under 100 to 400. How we increased from a few employees to 26 .

We must ask our Town Council to control all monies giving the DMO only 15% towards expenses 85% towards marketing like Beaufort Chamber operates.

Media members must demand the Chamber stop all selling of advertising and unfair competition and business practices towards its media members . I personally will file another lawsuit if this does not stop and feel many of us have damage claims as well. This can be proven as well.

Chamber is in violation of IRS tax laws governing 501-c6 non profits by operating and running for profit intent media products . This will be proven as well and if allowed or not enforced by IRS many for profit media like our company can convert to 501-c6 non profits like our media company and also legally avoid 35% corporate taxes , as well as apply for DMO and State grant monies , pay 400k salaries , hire 26 employees . I will inform IRS on this soon and make an announcement with full page ad in the Island Packet , Columbia Newspaper and Wall Street Journal my intentions that I will no longer pay corporate taxes to IRS for some of our media . We are awaiting the ruling on our Whistle blower case

From IRS this week to confirm our next step on this.

Please note , anyone can start a Local chamber , its not part of government , not a franchise and all independent . I have in fact set up several Chambers and CVbs in SC planning that IRS will not enforce this and will then open the door for me and many others in America to legally escape corporate taxes .
