I&R Center Webinar: NASUAD's 2015 State of the States

The National I&R Support Center will host a webinar on NASUAD's 2015 State of the States in Aging and Disability survey. This webinar is scheduled for Wednesday, December 9, 2015, from 3:00-4:00p.m. ET.

NASUAD's 2015 State of the States report provides detailed information on each state's long-term services and supports (LTSS) systems. This report is the result of a yearlong research project that collected information about the significant policy, fiscal, and operational issues occurring within each state. The results of the 2015 survey represent a snapshot of the current status of state government employees, the agencies that administer the programs, and the services that are provided. NASUAD's Senior Director Damon Terzaghi will present key themes and findings from the survey.

Medical Loss Ratio Report

On November 19th, the Centers for Medicare & Medicaid Services (CMS) published a new report that shows the premium rebate record since 2011. The Affordable Care Act requires that health insurance companies spend a minimum of 80% of premium dollars on health care, resulting in \$2.4 billion in consumer rebates since 2011. CMS' results indicate that consumers are receiving a higher value for their premium dollars as a result of the Medical Loss Ratio (MLR), 80/20 rule. This report examines rebated paid during the 2014 plan year, which was the first year that all of the Affordable Care Act reforms were in place.

#### ACL Published Independent Living Proposed Rule: Comments Wanted

On Monday, November 16th, the Administration for Community Living (ACL) published a proposed rule that will consolidate and streamline Independent Living regulations. The rule will provide information on the new requirements from the Workforce Innovation and Opportunity Act (WIOA). WIOA moved the Independent Living programs from the Department of Education to the Department of Health and Human Services (HHS) and the rule reflects the new regulations that will apply under HHS. The proposed rule has been published in the Federal Register with a 60-day comment period. Comments must be made through Regulations.gov, which provides an accessible portal for information regarding regulations. All comments must be submitted by Friday, January 15, 2016, at 5 p.m. ET.

#### Webinar: Comprehensive Care for Joint Replacement Model Final Rule

On Monday, November 16th, the Centers for Medicare & Medicaid Services (CMS) released the final rule for the Comprehensive Care for Joint Replacement (CJR) model. Use of the CJR model will begin on April 1, 2016, and holds hospitals accountable for the care they provide to Medicare fee-for-service beneficiaries during hip and knee replacements and other major procedures on the legs. CMS is holding a webinar to discuss the final rule and respond to questions from stakeholders. Pre-registration is required, large audiences are anticipated so please register early. This webinar will take place on Monday, November 30, 2015, from 2:00 p.m. to 3:00 p.m. ET.

#### Congress Passes Bill to Extend Medicaid Emergency Psychiatric Demonstration Project

On Monday, November 16th, the House passed Senate Bill 599, which would allow HHS to extend the Medicaid Emergency Psychiatric Demonstration Project. The demonstration was authorized by the Affordable Care Act as a way to test whether allowing reimbursement

for services provided in psychiatric hospitals improves the quality and cost of care. Under the provisions of the bill, the demonstration could continue in existing states, and HHS could authorize new states to participate, until the end of 2019 if the HHS Secretary and the CMS actuary certify there will not be an increase in overall Medicaid expenditures. The legislation also directs HHS to treat any increase in total Medicaid expenditures by a state due to the demonstration as an overpayment, subject to recoupment. The legislation previously passed the Senate and now heads to the President for his signature.
