> Obviously, there have been very significant General Fund investments

> at a number of agencies, some of which are under our direct

> jurisdiction, and some of which are not (Prosecution Coordination

> Commission, Attorney General).

> about the impact of those investments so far. I don't know how or

> through whom you'd like to reach out to these folks, but I'd be

> interested in getting some bulletpoints and/or narrative from the

> following:

> It's a short deadline, but I'd like it by noon Tuesday (sorry), since

> the themes will need to be complete just a couple days later. I'm

> open to their thoughts, suggestions, preferences, etc., but some

> natural candidates would be the reduction in automobile fatalities,

> maybe reductions in forensic backlogs...is there anything positive on

> recidivism, or the reduced inmate population... Fewer crimes, more

> arrests, you get the idea.

> Anyway, if we can get them started on this ASAP, I'd appreciate it.

> I'm copying the others here in case they have additional thoughts

> about what we'd like and/or what we might already have along these

> lines that we can work with. I'll work with whatever we can get, but

> again...big things are "most recent year vs. prior year" (whether

> calendar, fiscal,

> etc.) and/or "since the beginning of the administration."
