

The Budget Commission met in the Governor's Office, July 28, 1942, at four o'clock, all members being present.

Mr. Jeff B. Bates and Mr. J. E. Sprott appeared before the Commission and requested an allotment of \$750.00 from the Contingent Fund for National Defense to be used by the Columbia Squadron of the Civilian Air Patrol in training members of the patrol.

Mr. J. M. Wise, Mr. Coleman C. Martin, Mr. L. L. Hiott, and Mr. William B. Todd, members of the State Industrial Commission, appeared before the Budget Commission requesting that the Industrial Commission be allowed to reorganize the Commission through transfers of appropriations. After some discussion of the matter, the Budget Commission concluded that it should not make use of the authority granted under Section 72 of the General Appropriation Act to the extent of completely reorganizing a department when such reorganization contemplated the elimination of positions created by the General Assembly and the creation of new positions in a department, and the increasing or decreasing of salaries provided in the Appropriation Act. The Industrial Commission was informed, however, that the Budget Commission would cooperate in any minor transfers which might be requested and which did not substantially change the setup of the department.
