**A RESOLUTION

**WHEREAS**, Myasthenia Gravis (MG) is a rare, often misdiagnosed, autoimmune, neuromuscular disease that causes weakness of the voluntary muscles. Although controllable by medication and other treatments, it alters the lives of those affected and can be fatal; and

**WHEREAS,** because of its rarity (approximately 70,000 people are living with MG in the United States today), it is often difficult to diagnose correctly or in a timely manner; and

**WHEREAS,** the MGFA has a network of chapters throughout the United States including South Carolina whose mission is to facilitate the timely diagnosis and optimal care of individuals affected by myasthenia gravis and to improve their lives through programs of patient services, public information, medical research, professional education, advocacy and patient care.

**AN ORDINANCE**

**AUTHORIZING THE EXECUTION AND DELIVERY OF A FIRST AMENDMENT TO FEE AGREEMENT BETWEEN CHARLESTON COUNTY, SOUTH CAROLINA AND SOUTH CAROLINA ELECTRIC & GAS COMPANY; AND MATTERS RELATING THERETO.**

**WHEREAS,** Charleston County (the “County”), a public body corporate and politic under the laws of the State of South Carolina entered into a fee-in-lieu-of-property-taxes arrangement under the provisions of Title 12, Chapter 44 of the Code of Laws of South Carolina 1976, as amended (the “Act”) with South Carolina Electric & Gas Company (the “Company”) in connection with which (i) the County adopted an Inducement Resolution on October 6, 2009, and (ii) the County and the Company entered into a Fee Agreement dated December 30, 2009, (the “Initial Fee Agreement”);

**WHEREAS**, pursuant to Section 4.1 of the Initial Fee Agreement, the County agreed that the "Company may place Real Property and/or Personal Property into service at any time under this Fee Agreement;"

**WHEREAS**, the Company anticipates the addition of certain real property at the Project bearing the following TMS Numbers: 475-00-00-026; 475-15-00-002; and 475-00-00-018;

**WHEREAS**, the Company and the County desire to amend the Initial Fee Agreement so that the Project is defined to include the additional real property;

**WHEREAS**, Charleston County Council (the "County Council") has caused to be prepared and presented to this meeting the form of a First Amendment to Fee Agreement between the County and the Company (the "First Amendment"), which the County proposes to execute and deliver;

**WHEREAS**, it appears that the First Amendment, which is now before this meeting, is in appropriate form and is an appropriate instrument to be executed and delivered or approved by the County for the purposes intended;

**NOW, THEREFORE, BE IT ORDAINED** by the County Council in meeting duly assembled as follows:

**Section 1.** The County finds that the form, terms and provisions of the First Amendment which is before this meeting and filed with the Clerk to County Council is hereby approved and all of the terms, provisions and conditions thereof are hereby incorporated herein by reference as if the First Amendment was set out in this Ordinance in its entirety. The First Amendment is to be in substantially the form now before this meeting and hereby approved, or with such changes therein as shall be approved by the officials of the County executing same. Provided, this approval of the First Amendment shall require the written consent of J. Steven Dykes, Director, Charleston County Economic Development to be deemed amended.

**Section 2.** The Chairman of County Council and the Clerk to County Council, for and on behalf of the County, are hereby each authorized and directed to do any and all things necessary to effect the execution and delivery of the First Amendment and the performance of all obligations of the County under and pursuant to the First Amendment.

**Section 3.** The consummation of all transactions contemplated by the First Amendment is hereby approved.

**Section 4.** This Ordinance shall be construed and interpreted in accordance with the laws of the State of South Carolina.

**Section 5.** The provisions of this Ordinance are hereby declared to be separable and if any section, phrase or provision shall for any reason be declared by a

court of competent jurisdiction to be invalid or unenforceable, such declaration shall not affect the validity of the remainder of the sections, phrases and provisions hereunder.

**Section 6.** All orders, resolutions, ordinances and parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed and this Ordinance shall take effect and be in full force from and after its passage and approval.

The Consent Agenda is as follows:

A report was read from the Finance Committee meeting of June 2, 2011 that it considered the information furnished by Allen O'Neal, County Administrator, and Rae Wooten, Charleston County Coroner, regarding permission for the Coroner's Office to apply for a SC Department of Public Safety Office of Justice Programs for a grant of \$45,000 to improve the quality and timeliness of forensic services and medical examiner services. It was stated that the Coroner's Office is requesting these funds for a one-year, full time Paralegal/Forensic Data Entry Assistant and to purchase equipment which will assist that individual in their position.

Committee recommended that Council approve the Coroner's request to apply to the SC Department of Public Safety Office of Justice Programs for a grant in the amount of

\$45,000 to employ a one-year grant funded position, with the understanding the County is under no obligation to support the costs associated with this FTE at the end of the grant period; that no match is associated with this grant and the grant period runs from October 1, 2011 through September 30, 2012.

A report was read from the Finance Committee meeting of June 2, 2011 that it considered the information furnished by Allen O'Neal, County Administrator, and Steve Dykes, Director of Economic Development, regarding a set-aside grant. It was stated that set-aside grants are "pass thru" grant funds made available to the host County in which the Company resides. It was further stated that the S. C. Coordinating Council for Economic Development is expected to approve the \$50,000 Set-Aside grant for Odfjell Terminals (Charleston), LLG at its June 2<sup>nd</sup> meeting, and this action requests the Charleston County Council to formally accept the grant into the County's grant management system when the grant is awarded and following an award contract signing later in June, the Company will be informed of the available funds.

Committee recommended that Council authorize the County to accept the \$50,000 Set-Aside grant from the S. C. Coordinating Council; for Economic Development, acting as administrator and conduit for the passage of the funds to Odfjell Terminals (Charleston), LLC on a reimbursable basis.

A report was read from the Finance Committee meeting of June 2, 2011 that it considered the information furnished by Allen O'Neal, County Administrator, and Scarlett Wilson, Ninth Judicial Circuit Solicitor, regarding funding from the State for the Ninth Judicial Circuit Juvenile Drug Court. It was stated that Probate Judge Irvin Condon and Judge Tamara Curry have agreed to preside over the Juvenile Drug Court and have been approved by Chief Justice Jean Toal to do so. It was shown that in addition to their current duties for the adult court and the mental health court, the solicitor requests that County Council approve salary increases for Judge Irvin Condon and Judge Tamara Curry

Committee recommended that Council approve the request of the Solicitor's Office for an increase in salaries for Judge Irvin Condon and Judge Tamara Curry from \$120,939 to \$130,312 for assignment to preside over the Ninth Circuit Juvenile Drug Court retroactive to February 7, 2011 and for handling the Ninth Judicial Circuit Adult Drug Court and the Mental Health Court.

**Public  
Forum**

The Chairman asked if any Member of the Audience wished to address Council.

Mr. David Coe, of James Island, addressed Council regarding changing the boat situs rules from 90 days to 180 days. He also commented on the Auditor's budget.

In response to Mr. Coe's comments, Council Member Darby requested a presentation regarding the pros and cons of the 90 days vs. 180 days boat situs.

Mr. Chris Fisher, of Fisher Recycling, addressed Council regarding the Business Recycling pilot program. He stated that he had allowed the County's contractor, Mitch Kessler, to come into his warehouse and in his opinion Mr. Kessler had

scouted his business model. He stated that he would like the County to rescind its pilot program as he thinks it is competing with the public sector.

In response to Mr. Fisher's comments, Council Member Schweers requested an update on the various pilot programs the County has recently undertaken in the Environmental Management Department.

In response to Mr. Fisher's comments, Council Member Condon stated that in her view, the pilot program is not picking up recyclables from businesses for free since the businesses do pay a solid waste user fee.

Mrs. Elizabeth Fisher, of Fisher Recycling, stated that she opposes the business recycling pilot program and encouraged Council to try to increase recycling for single-family and multi-family residences, schools, and parks. She stated that she wants recycling to succeed, but feels like the County's pilot program is cutting into her business.

Mr. John Votaw, of Southeastern Plastic Recovery, stated that he had served on the Green Ribbon Committee and would like to see Council reconvene that body. He also stated that he would like to see the County somehow incentivize recycling, perhaps by giving businesses a reduced business license fee if they participate in recycling.

Ms. Jessica Monday stated that she opposes the business recycling pilot program and would like to see Council incentivize residential recycling.

Mr. Barry Wolf, Vice-President of Charleston Steel and Metal Company and President of the SC Recycling Association also spoke against the business recycling pilot program.

Ms. Mary Graham, of Charleston Metro Chamber of Commerce, stated that the Chamber has concerns regarding where the County's business recycling program is heading and offered the assistance of the Chamber of Commerce as a convener to help facilitate open dialogue between the County and the business community regarding the future of the County's program. She also stated that the Chamber objects to "flow control" or mandated recycling for businesses.

Charleston County Auditor Peggy Moseley stated that there is a difference between the public helping her department uphold the tax laws in the County and harassment. She stated that she believed the County would be better served by reducing the tax rate for boats from 10.5% to 6% as has been done in other coastal counties. She also recognized two of her employees, A.J. Nichols, code enforcement officer, and Mike Roumillat, boat tax specialist.

Hearing no further public comments, the Chairman asked if any member of Council wished to address the body.

Council Member Condon thanked staff for their work on what has so far been a smooth budget process.

Council Member Schweers thanked the recycling community for bringing their concerns to Council and stated that the County is doing its best to put out the best recycling program for its citizens.

Council Member Darby remarked that Mack Gile is a man of great intellect and that Mr. Darby is proud that Mack Gile works for Charleston County.

Council Member Johnson thanked Peggy Moseley and her employees for coming to the meeting and stated that she was saddened to hear that they think they are being harassed.

Council Member Sass thanked staff for keeping the County pointed in the right direction. He also thanked the recycling community and Mrs. Moseley for being at the meeting tonight.

Council Member Rawl stated that the state sets three tax rates for real and personal property in South Carolina and it is up to the County to decide which category each piece of property is classified in.

Chairman Pryor stated that he would like the upcoming presentation on the solid waste program to include information about franchise fees and tipping fees for recycling.

There being no further business to come before the Body, the Chairman declared the meeting to be adjourned.
