This is like both of you as my partner in a business ,I am the managing partner and I tell you that under SC law you are not entitled to certain financial information . This partnership would be short lived correct ?

What I have been forced to do now is take this to litigation and SC Supreme Court if necessary . I will continue full

who are interested . Will launch a direct mail piece to be sent out. I have filed an IRS Whistle Blower case and have put extreme pressure on IRS to enforce the 100% proven violations to 501-c6 tax codes governing non profits by our Chamber . IRS has been told by me and my team of lawyers and accountants if they do not enforce their own tax codes , I and other media nationwide will and can simply set up parts of our media companies the exact same way as the Hilton Head Bluffton Chamber with our media assets and stop paying corporate taxes and do so fully transparent and legally in their face not offshore facing prison. This was a shocking revelation for IRS and they have never in the history of IRS been faced with this situation or someone telling them this . Further my case has spread nationwide and is being called one of the largest Whistle Blower cases in US history and now followed by many big media.

I have instructed my lawyers and accountants to put together additional Lawsuits that will be filed at the appropriate times as this Foia case moves forward in the courts and we receive the response we fully expect from the lawyers in Charleston and the current buddy board and Bill Miles. The only way to prove some of this is with a total complete third party audit not the audit the Chamber hired to do. Note much of this can and will be proven thru litigation , depositions and discovery . Ray Deal the chamber in house controller and others will have lots of questions and detailed answers needed .

Town council , this State must think about its fiduciary responsibilities before just handing out money to someone without fully understanding how this money is being used. Drew you just got a raise to 30k annually, Gov Haley at 106k , President Obama 400k , Bill Miles at who knows exactly 400k could be more after we see Real numbers .Duane Parrish is he same or more than the Gov ? Just

this alone not counting all the rest is simply out of control . By Bill Miles and his band of lawyers refusing information and transparency makes it all 10x worse . Who pays for the lawyers ? Who now pays for the Chamber ads in the local magazines that say "I Am The Chamber " using local businesses to say how great the Chamber is when we all know this is because Chamber membership is dropping fast, how does this help promote our island ? . 1000x 400 just to pay one salary , not even 26 more employees and all the rest .
