I am the mother of Zachary N. Morgan, inmate 344197. His parole hearing is March 18, 2015. This will be his third visit. I am requesting an inquiry of the Parole Board Members to see if they are "each" receiving the information material that is being sent to all the members. I have been reading the Parole Board Handbook and I think the offender families deserve more than "Due to the nature of the crime", as the reason for not granting parole because that tells us nothing. I know you don't have anything to do with the parole process but, you are responsible for the selected board members and their manner in which they function. I don't know who to consult to find out if all of the board members have a say in the decision or just the 2 or 3 that comes for the hearing. I question if the past information that was sent certified mail, reached all the individuals. I requested a visit of the hearing and did not get a response. This is part of the process the handbook guidelines. Who are the gate keepers for the board? He is a non-violent, after the fact offender that has met the requirements for parole. He has recommendations, a job offer in what he is presently doing, as well as other job opportunities in the community.

On January 18, 2014, I faxed and certified mailed information to each board member pertaining to consideration for Zachary's parole support. Each board member had an individual packet addressed to them that was mailed in one box because I did not have each members address. I don't think they received it. At the hearing the three members present was just getting the faxed letter from the lawyer and they all did not read it. I was watching the assistant hand them the paper. It seems the decision is made before we get

there because we answer the same questions and send reasons for them to support parole, only to get the same answer without going down the guidelines of the handbook. March 20, 2014, my request to revisit the parole decision went unnoticed with no response. It is written in the handbook that we have the right to petition and they are mandated to follow the rules. I am a court mandated guardian. I am not allowed nor would I, not respond or not give essential information to all persons that are part of my cases. I am just asking for checks and balances because that is the only way to keep everything honest and upfront for all parties
