## **Aging with Health and Dignity: Diverse Elders Speak Up**

In 2016, the Diverse Elders Coalition partnered with Caring Across Generations to collect nearly 5,000 comments from our communities about what individuals need to age with health and dignity. Comments were collected in six languages from all 50 states and provided a snapshot of the challenges of aging in communities of color, LGBT communities, and American Indian/Alaska Native communities.

These comments were synthesized into a series of recommendations for policymakers and service providers that can be found in the report, "Aging with Health and Dignity: Diverse Elders Speak Up." Based on the comments, the Diverse Elders Coalition recommends the following to legislators and policymakers as they shape aging programming in the United States: culturally and linguistically competent services for elders; greater support for aging-in-place, especially policies that support affordable housing and livable communities in urban and underserved rural areas, including Indian Country, Alaska Native villages, and Hawaiian Home Lands; and accurate, disaggregated data collection about our communities. ## **Disruptive Innovation in Medicaid Non-Emergency Transportation**

The Center for Health Care Strategies released a new issue brief which outlines the current state of Medicaid non-emergency medical transportation (NEMT) services, including challenges and opportunities for improvement. It explores innovative alternative models being piloted by states and health plans across the country to expand NEMT options.

This brief, a product of the Complex Care Innovation Lab made possible by Kaiser Permanente Community Benefit, explores alternative transportation models piloted by states and health plans across the country, including the use of transportation network companies, such as Uber and Lyft, to augment NEMT services.

#### **CMS Federal Medicaid Director Named**

On March 2<sup>nd</sup>, Modern Healthcare reported that Brian Neale has been selected to lead the Center for Medicaid and CHIP Services (CMCS) at the Centers for Medicare and Medicaid Services (CMS). In the role Mr. Neale will have responsibility for leading the Federal Medicaid program, which includes oversight of

Medicaid LTSS services. Brian Neale was previously the healthcare policy director in Indiana during Vice President Mike Pence's time as Governor. In that role, he worked closely with Seema Verma, who is awaiting final confirmation to lead CMS.

## National Center for Health Statistics

### **New Maps Based on National Study of Long-Term Care Providers**

The Long-Term Care Statistics Branch (LTCSB) at the National Center for Health Statistics (NCHS) has released two new products using data from the 2014 wave of the National Study of Long-Term Care Providers (NSLTCP). The first is a map and Powerpoint of selected characteristics of residential care communities and residents in the United States. The second set is maps of selected characteristics of adult day services centers and participants in the United States. Characteristics include center ownership and chain status; disease specific programming, practices, and revenue sources; and participant functioning, health conditions, and adverse events.

## House Continues to Develop ACA Repeal and Replacement Policies

On Friday, February 4th, the news outlet Politico released a copy of legislation being drafted by Republican Leadership in the House of Representatives that is intended to repeal and replace the Affordable Care Act. The legislation would effectively terminate the bulk of the Affordable Care Act at the end of 2019. A wide range of policies are proposed to be terminated on December 31, 2020 with significant changes to the Medicaid and the insurance marketplace taking effect simultaneously. The bill includes proposals such as:

- \* Repealing the ACA advanced premium tax credits (APTCs) which are used to subsidize the purchase of health insurance on the exchanges;
- \* Repealing ACA taxes, including the increased Medicare tax; the tax on high-cost health plans; the health insurer tax; and the medical device tax, among others;
- \* Establishing a new tax credit to purchase insurance that is based upon age rather than income:
- \* The credit would vary from \$2,000 for individuals younger than 30 to \$4,000 for individuals over 60.
- \* Eliminating the increased Federal matching rate (FMAP) for 1915k/Community First Choice services;
- \* Rescinding increased FMAP for the ACA expansion group;
- \* Setting a per-capita cap on Medicaid expenditures; and
- \* Providing \$100 billion in grants to states in order to establish programs that support the insurance marketplace and individuals with significant health conditions.

Final policies that will be included in the ACA repeal/replace package are still very much under discussion. In the Senate, several Republicans have previously expressed reservations and concerns about some of the policies that were included in this draft bill such as the repeal of Medicaid expansion, the implementation of per capita caps, and a policy to end funding for Planned Parenthood. In the House, a number of conservatives expressed concern about the establishment of a new entitlement via the refundable tax credit. Separately, President Trump endorsed many of the policies included in this draft legislation during his speech to Congress on Tuesday. Specifically, he recommended expanding the use of Health Savings accounts and providing refundable tax credits to assist with the purchase of insurance.

More recently, Republican leadership has continued updating the legislation. Several news outlets have reported that a new copy of the bill is being shared with members of the Energy and Commerce committee, which is responsible for many of the repeal and replace policies. Reporting indicates that the legislation is being protected in a reading room, where some members may view the bill but not remove any copies of the policy. The legislation is expected to be considered in the Energy and Commerce committee this month, potentially as early as next week.

### **National Nutrition Month Presentations**

In recognition of National Nutrition Month, Mathematica presents a five-part series summarizing our research on an array of nutrition topics. This first installment spotlights recently published findings on the effectiveness of summer electronic benefit transfers (EBTs) in improving food security and dietary intakes among school children during the summer, when they do not have access to school meals. Findings showed that the \$60 benefit substantially reduced food insecurity during the summer and also improved consumption of nutritious foods, including fruits, vegetables, and whole grains.

## Report Addresses Aging Prisoner Population

America's prison population is aging rapidly. Between 2007 and 2010 the number of state and federal prisoners age 65 and older grew at a rate 94 times the overall prison population, making it the fastest growing demographic. The increase can be attributed to a variety of factors including the aging of the overall U.S. population, longer prison terms due to factors such as mandatory sentencing, and an increase in the number of older people committing crimes. The challenges and opportunities associated with the U.S. aging prisoner population have gained more attention in recent years with increases in research and media coverage. With funding from the U.S. Department of Health and Human Services' Administration for Community Living (ACL), a new report examines trends in the U.S. aging prison population and focuses on the role of the Area Agencies on Aging (AAAs) in helping to address the needs of this population. Data was gathered through a poll of n4a's members on the topic as well as follow-up interviews with a select number of AAAs that are implementing projects related to the aging prisoner population.
