Governor Nikki Haley News:

Associated Press: SC's Gov. Haley 'not interested' in vice presidential slot

Gov. Nikki Haley says she's "not interested" in serving as a vice presidential nominee. Haley said in a statement provided to The Associated Press Wednesday that she's "flattered" to be mentioned as a possible running mate but that her "plate is full" governing South Carolina. Haley's star has risen due in part to her response to the Charleston church shooting and South Carolina's historic flooding. She gave this year's Republican response to President Barack Obama's State of the Union address. The statement came in response to questions about whether Haley would support Donald Trump as the GOP's nominee, now that other candidates have left the race.

Republican elected officials, donors and strategists grappled uncomfortably on Wednesday with the inevitability of Donald J. Trump as their presidential nominee, an unexpectedly sudden denouement that left many in a state of political paralysis and others vowing to oppose the party's new standard-bearer. While some called for unity, many Republican leaders refrained from falling in line behind Mr. Trump, with dozens avoiding inquiries about where they stood or saying they wanted Mr. Trump to detail his policies or tone down his language first. Others tied themselves in knots as they praised and criticized Mr. Trump in a single breath, or suggested that they could abide Mr. Trump but loathed his agenda.

Note: And Gov. Nikki R. Haley of South Carolina, who supported Mr. Rubio and had castigated Mr. Trump at times, issued a statement Wednesday reiterating that she would support "the Republican nominee for president." A spokesman for Ms. Haley said she and Mr. Trump had not spoken.

Republicans woke up Wednesday morning to the realization that Donald Trump, once the host of a TV reality show, had finally defeated the last of his 17 GOP primary rivals and would almost surely become the party's 2016 presidential nominee. The reaction from top Republicans in the Carolinas? Mixed.

Note: The governors of South Carolina and North Carolina repeated their months-old pledges to back the eventual GOP nominee without mentioning Trump by name. "I have great respect for the will of the people, and as I have always said, I will support the Republican nominee for president," S.C. Gov. Nikki Haley said in a Wednesday statement. But she also discouraged widespread speculation that she might end up as Trump's

running mate.

Note: Ricky Diaz, a spokesman for N.C. Gov. Pat McCrory, who is running for a second term this year, said this: "The governor has always said he will support the GOP nominee, but the real question is will (Democratic gubernatorial nominee) Roy Cooper support Hillary Clinton or Bernie Sanders?"

A House panel will hold its second hearing Thursday on a bill that would require refugees register with the state and be tracked by law enforcement. Lawmakers met last week and heard testimony from more than 20 people, all who spoke against the bill. The legislation, introduced by Roebuck Republican Sen. Lee Bright and approved by the Senate earlier this year, would place all refugees who are resettled in South Carolina on a registry with the S.C. Department of Social Services and require they be tracked by the State Law Enforcement Division.

Politicians in South Carolina have revived a plan that curtails the public's right to sue for enforcement of state pollution laws — and the bill is within a House vote of passing the Legislature. The House Judiciary Committee voted 13-10 this week for legislation blocking citizens from suing under state law to stop corporations, utilities and others from contaminating the environment. The bill, approved by the Senate more than a year ago, appeared to be dead in the House until it was put on the Judiciary Committee agenda for a vote this week. Note: The bill could be discussed by the House as soon as today, but is expected to be debated in about two weeks. If the House approves the bill, it would go to Gov. Nikki Haley for consideration.

Richland County senators pushed for local projects to be included in \$40.4 million of wish-list spending given approval Wednesday as part of the state budget. Whether the \$40.4 million ever is spent will depend on whether state budget forecasters say lawmakers will have extra money in the state budget that takes effect July 1. If forecasters add extra money to the state budget, \$10 million will be spread across S.C. colleges to pay for overdue maintenance projects, a cause supported by state Sen. John Courson, R-Richland.

House lawmakers asked questions but took no action Wednesday on a Senate plan that would convert bonds into a \$4 billion funding package to widen interstates, eliminate every load-restricted bridge on state secondary roads and pave primary routes. The legislation is eventually to be married with governance reforms for the state's highway agency in negotiations that will take place in the Legislature's waning weeks of this

year's session.

Note: Rep. Chip Limehouse, a Charleston Republican who chaired the hearing, told The Greenville News no action would be taken on the bill until lawmakers from both chambers agree on a package. He called the Senate plan a "wobbly punt" by the Legislature this year toward addressing the state's massive infrastructure needs.

Giving no indication of yielding to pressure, North Carolina's Republican leaders called a federal warning about the legality of the state's new law limiting LGBT anti-discrimination rules a broad overreach by the government. Gov. Pat McCrory and top state legislators were determining what steps to take after the U.S. Justice Department said in a letter Wednesday that the state law violated federal civil rights laws and threatened possible litigation. "This is no longer just a North Carolina issue, because this conclusion by the Department of Justice impacts every state," McCrory said.

A report about the practices of farmers who sell tobacco to R.J. Reynolds shows that several growers had children under the age of 13 working in their fields despite a pledge by the company to ban the hiring of people so young. The report by a consulting company and released Wednesday by a pro-worker group shows that five non-family minors under the age of 13 were working in the fields at the time of the assessment.



Note: Of the 505 workers interviewed, five identified themselves as being 15 to 17 years old. All five worked full-time on South Carolina farms and all said they were local to the area in which they worked.

The incident took place near where Deontea Mackey would fatally shoot Jacobs on March 18, behind a house on Rebecca Street. Moments after killing Jacobs, Mackey would kill himself. The footage gives a brief glimpse of 16-year-old Mackey and how he interacted with police in a case where he would plead guilty to a felony. Jacobs was his arresting officer.

In April, Craven pleaded guilty to official misconduct in office for his role in the February 2014 shooting death of Ernest Satterwhite Sr. Circuit Judge Frank Addy Jr. sentenced Craven to three years probation with 80 hours of public service.

If secrecy fuels the stigma that surrounds mental illness, Patrick Kennedy says, then speaking out about one's illness can be a powerful tool to defeat it. "In my book, 'A Common Struggle,' I said that we are only as sick as our secrets," said Kennedy, son of the late U.S. Sen. Ted Kennedy and former U.S. Congressman from Rhode Island, who will share his story of mental illness and addiction at the Southeastern Symposium on Mental Health in Greenville on Saturday. "Today, that's the mantra of my life," he told The Greenville News, "and speaking out is something I encourage others to do."

Note: About 43.8 million people — or one in five Americans — has a mental illness, according to the South Carolina Institute of Medicine & Public Health. And 10 million of them suffer from a serious condition such as schizophrenia or bipolar disorder.

Associated Press: Florida Supreme Court considers overturning death sentences

The lives of nearly 400 death row inmates hang in the balance during oral arguments Thursday before Florida's Supreme Court, which will ultimately decide if their sentences should be reduced to life in prison. The hearing comes in response to a U.S. Supreme Court ruling earlier this year that found Florida's system of sentencing people to death unconstitutional. The nation's high court said Florida's system gave too much power to judges, rather than juries, in imposing capital punishment. The Florida Supreme Court will not rule Thursday but use the arguments to help decide whether to reduce the sentences of the state's 389 death row inmates.

If 2016 has been the Year of Trump in politics, it may also end up being a new Year of the Woman, if Democrats get their way. And that won't be a coincidence. This is what victory looks like in the Iraqi city of Ramadi: In the once thriving Haji Ziad Square, not a single structure still stands. Turning in every direction yields a picture of devastation. A building that housed a pool hall and ice cream shops — reduced to rubble. A row of money changers and motorcycle repair garages — obliterated, a giant bomb crater in its place. The square's Haji Ziad Restaurant, beloved for years by Ramadi residents for its grilled meats — flattened. The restaurant was so popular its owner built a larger, fancier branch across the street three years ago. That, too, is now a pile of concrete and twisted iron rods.
