### SUMMARY REPORT

Meeting of Commission on Higher Education, September 8, 1983

Recommendations of the Commission for 1984-85 appropriations for current operations of the State public colleges and universities and the State Board for Technical and Comprehensive Education instructional programs are summarized below. The Commission agreed to defer consideration of requests for computing equipment, new and replacement equipment, and deferred maintenance pending completion of studies of such needs at the colleges and universities.

The Commission is scheduled to make its recommendations concerning 1984-85 appropriations to the Budget and Control Board, the House Ways and Means Committee, and the Senate Finance Committee on September 14, 1983.

PERMANENT IMPROVEMENT REQUEST

The Commission approved a proposal for authorization to construct a radio station transmitter building at South Carolina State College.

LIFTING OF MORATORIUM ON MEDICAL EDUCATION PROGRAMS

The Commission imposed on April 7, 1983, a one-year moratorium on all new medical education programs with the understanding that the moratorium would be lifted earlier if coordination of the State's medical schools is enhanced. On July 7, 1983, the Commission endorsed a cooperative agreement by the Medical University of South Carolina, the University of South Carolina, and the Office of the Governor, with representation from the Commission, to establish a coordinating

board for medical education. Because this coordinating board is functioning, the Commission voted to lift the moratorium on medical education programs.

PREVENTIVE MEDICINE  
RESIDENCY, USC  
SCHOOL OF MEDICINE

The Commission approved a proposal to initiate a medical doctor residency program in preventive medicine at the USC School of Medicine in July 1984. Areas of specialization within the program include general preventive medicine, public health, and occupational health.

RENEWAL OF  
LICENSURE OF SHAW  
UNIVERSITY

The provisional license of Shaw University, Raleigh, North Carolina, to operate in South Carolina was renewed for one year, expiring on May 1, 1984. Shaw was first licensed to operate in the State on May 1, 1980, under Act 201 of 1977, which provides for licensure by the Commission of non-public institutions to operate in South Carolina.
