South Carolina Gov. Nikki Haley, likely to be on the short list of running mates for whomever wins the Republican nomination, will keynote this year's Tennessee Republican Party Statesmen's Dinner. "I am thrilled to welcome Governor Haley to the Volunteer State as the keynote speaker of the 2016 Statesmen's Dinner," stated TNGOP Chairman Ryan Haynes. "Guests at the Statesmen's Dinner have come to expect dynamic messengers for the Party and Governor Haley certainly fits that role. I look forward to hearing from the Governor about her solutions to unite our country and heal the divisions we've witnessed over the last seven years." Haley is routinely mentioned as a potential 2016 Vice Presidential candidate for the Republican Party.

former South Carolina senator who resigned amid an ethics investigation and who returns to court next month for violating probation is seeking his old Senate seat. Robert Ford of Charleston filed this week to run for the Senate seat he held for 20 years before resigning in 2013. He was sentenced last May to five years of probation after pleading guilty to misdemeanor charges of misconduct in office, forgery and ethics law violations. He was also ordered to pay \$70,000. According to the state's probation agency, Ford must appear in court April 11 for missing nearly \$9,000 worth of monthly payments. A judge could sentence him to jail time.

A long week looms for House members when they return to the chamber Monday afternoon. Representatives will debate and amend the \$7.5 billion budget the House Ways and Means Committee has approved. Budget staff members are drafting amendments and preparing over the weekend for the slog. Amendments are already coming in, such as one from Rep. Mike Pitts, R-Laurens, that adds \$2.9 million for new criminal domestic violence prosecutors and \$1.1 million for three judges to handle an increased caseload. South Carolina is one of just three states in the country where police officers, not attorneys, are called upon to prosecute domestic violence crimes in the courtroom.

Civil rights movement veterans and U.S. Reps. Jim Clyburn and John Lewis are leading more than a dozen members of Congress on a three-day history and race relations tour of South Carolina, culminating Sunday with services at the Charleston church where nine black parishioners were gunned down last June. The event comes during the vitriolic and sometimes violent presidential campaign season that has seen blacks and whites face off at rallies for Republican Donald Trump. Just 150 miles away, a white Trump supporter was captured last week on video punching a black protester who was being escorted from a North Carolina rally. Both Democrats and Republicans are part of the civil rights tour, including GOP South Carolina Sens. Tim Scott and Lindsey Graham, a one-time candidate for president.

Cargo volume continues to increase at South Carolina's ports. The South Carolina Ports Authority board was told Thursday that container volume is up more than 4 percent since the fiscal year started

last July. Authority president and CEO Jim Newsome says container volume last month showed a modest gain compared to February of 2015. Newsome said he expects continued increases in the coming months. In February, the ports handled the equivalent of nearly 160,000 20-foot shipping containers, an increase of more than 3 percent over February of last year.

Travelers passing through South Carolina's busiest airport will be able to reflect on last year's shooting at Mother Emanuel AME Church. Plans were unveiled Thursday for a memorial in an alcove at the Charleston International Airport terminal. Local media outlets report the memorial will include stained glass etched with the names of the victims and survivors. It will also include a table with a Bible open to the Scripture being read at the time of the shootings. The memorial will also have photographs of the church and a seating area. The \$175,000 for the memorial is being raised through private donations. Nine people were shot and killed during a Bible study at the church last June.

The clock is ticking on an expiring voter-approved bond referendum to fund a performing arts center before 2018, making the project a potential priority in next year's budget. An already-delayed beach renourishment project – which will begin June 15, according to a Friday news release from the town of Hilton Head – could affect both the nesting and hatching processes of Hilton Head Island's sea turtles. "The issue is that the new time frame is right in the middle of nesting and hatching season," said Amber Kuehn, manager of the Coastal Discovery Museum's Sea Turtle Protection Project. "So now we don't have to just worry about nesting females, we have to worry about hatchlings, too." Nesting season officially begins in May and runs through October, according to the South Carolina Department of Natural Resources' website. Hatchlings often begin appearing in early July, Kuehn said. She and her staff will be on patrol just like they are every year, ready to relocate nests to safer areas.

Last fall, some Charlotte City Council members were so concerned about local media reporting on their private conversations during closed session meetings that they asked city staff to investigate whether reporters were bugging them. The issue has long rankled city officials, but a September story

in the Observer about negotiations between the city and former police officer Randall “Wes” Kerrick was particularly frustrating to former at-large council member Michael Barnes. Kerrick, who shot an unarmed man in 2013, resigned from the city in October 2015 after receiving nearly \$180,000 in back pay and benefits. In an email to his colleagues, Barnes pleaded for quiet. He was frustrated that details of the negotiations were published “practically before we left the building.”

David Crane spent six years as a high school teacher and coach in Georgia, where the schools grade on a 10-point scale. That could happen as early as the 2016-17 school year. Molly Spearman, the state’s superintendent of education, addressed the South Carolina Athletic Administrators Association Monday in Charleston and discussed the move from a 7- to a 10-point scale. Department of Education spokesman Dino Teppara said Spearman will present a proposal to the State Board of Education for its review this spring or summer. The uniform grading policy working group is still putting together the proposal, so Teppara could not comment on what grade levels would be affected. Its recommendations have not been finalized.

The deputy mayor of the Brussels neighborhood of Molenbeek says he's received confirmation from the Belgian federal prosecutor's office that Paris attacks fugitive Salah Abdeslam has been shot in the leg and detained. Ahmed El Khannouss tells The Associated Press that Abdeslam was hurt and police have taken him away. He says police are still searching for one person who is holed up in a house. Abdeslam has been on the run since the November attacks that killed 130 people.

The main fugitive from Islamic extremist attacks in Paris in November, Salah Abdeslam, has been arrested in Belgium's capital after four months at large, French police officials said Friday. The officials told The Associated Press that he was arrested Friday in a major police operation in the Brussels neighborhood of Molenbeek. Both officials are in contact with people involved in the operation and spoke only on condition of anonymity because they were not authorized to speak publicly about an ongoing operation. Abdeslam, 26, was among the attackers who killed 130 people at a rock concert, the national stadium and cafes on Nov. 13 in Paris.

The American Islamic State group fighter who handed himself over to Kurdish forces in northern Iraq earlier this week said he made "a bad decision" in joining the IS, according to a heavily edited interview he gave to an Iraqi Kurdish television station. In the TV interview, which aired late Thursday night, Mohamad Jamal Khweis, 26, from Alexandria, Virginia detailed his weeks-long journey from the United States to London, Amsterdam, Turkey, through Syria and finally to the IS-controlled Iraqi city of Mosul. "I didn't agree with their ideology," he said, explaining why he decided to escape a few weeks after arriving. "I made a bad decision to go with the girl and go to Mosul."

The Air Force is investigating 14 members of a nuclear weapons security force for alleged illegal drug activity, in some cases including cocaine use, defense officials said Friday. The probe is a fresh blow to a nuclear missile corps that has been under intense scrutiny for a string of lapses in training and personal conduct over the past three years. The investigation at F.E. Warren Air Force Base, home of the 90th Missile Wing, near Cheyenne, Wyoming, was announced by Gen. Robin Rand, the four-star commander of Air Force Global Strike Command. The command is responsible for the entire fleet of Minuteman 3 land-based nuclear missiles; one-third of the Minuteman 3 force is operated by the 90th Missile Wing in missile fields in portions of Wyoming, Colorado and Nebraska.

Most Americans support it. Virtually all other developed countries already do it. And the two leading presidential candidates on both sides of the aisle agree: the federal government should lower drug prices. But experts say the chances for government action in the near-term are close to nil. The reasons are familiar: political gridlock in Washington, pharmaceutical industry influence and the structure of the U.S. health system itself, which limits government intervention. Looking ahead, a Democratic president with majorities in the House and Senate might be able to pass major pricing reforms. But even if Democrats retake the Senate this year, Loss and others don't expect Democrats to regain the House.

"No, no. Not going to do it," she told the packed convention center crowd in liberal Austin. She mentioned her teenage daughters, Malia and Sasha, as two of the main reasons. "The daughters of a president. Just think about it. Come on, young people. Not so easy," Mrs. Obama said. "They've handled it with grace and with poise, but enough is enough." She also says she won't disappear from public view or slow down once she leaves the White House next year. "Sometimes there's much more you can do outside the White House without the constraints, the lights and the cameras, and the partisanship," Mrs. Obama said. "There's a potential that my voice can be heard by many people who can't hear me now because I'm Michelle Obama, the first lady. I want to be able to impact as many people as possible in an unbiased way to try to keep reaching people. I think I can do that just as well by not being president of the United States."

A so-called "open" convention, they think, is the only way to stop Trump from heading the ticket in November. It would be historic, exciting — and chaotic. "It's not going to be pretty," said Kenneth Warren, a political science professor at St. Louis University. Some GOP leaders think the danger of a Trump candidacy is worth the risk of a unique, messy gathering in Cleveland. "It may be the only real

remaining route,” U.S. Rep. Bill Huizenga, a Michigan Republican, told The Hill newspaper last week. “If that is the case, then, you know, let’s move boldly into it.” But other Republicans say disregarding votes cast in primaries and caucuses would infuriate supporters of the front-runner, and permanently rip the party apart.

The battle over Yosemite National Park trademarks is now sprawling across multiple fronts, and it could take more than a year to sort out. Going on the offensive, the National Park Service has formally urged the Trademark Trial and Appeal Board to cancel the Yosemite-affiliated trademark registrations secured by the famed park’s former concessionaire. The former concessionaire’s attorneys, in turn, have called the National Park Service’s trademark cancellation demands “particularly astounding,” and they are urging the trademark board to back off until a separate lawsuit is resolved in the U.S. Court of Federal Claims.
