Tony, if I understand the problem (and I am not an accountant) the reports we filed and which were approved (paid) June 30, 2014 reflected in some cases a lower carry over amount than that shown on the FY 2015 NGA. For instance in III-C-2, we showed a carryover of \$23,365 at June 30, 2014 and were paid based on that report. The new NGA shows a carryover of \$61,854 in that line item. The auditors contend that there is no explanation as to the difference in amount. Possibly we are missing something as I did not see anything extra filed with the NGA other than the letter which indicates there is an adjustment in administrative and service awards. It does not indicate that this was applied to carryover – which may be the case. I just need something in writing to send to the auditor that states why there are differences in this particular line item. If that is not possible, let me know and I will relay that to the auditor. It will probably result in a note to the financials for this year and then again for next year as the amounts cannot be reconciled. Thanks for your help. I hate to be a bother on this but our auditing firm is very thorough, which we like, and we try to give them all we can to keep the notes to a minimum.
