States Review Longstanding Alcohol Laws

In recent years, many jurisdictions have modernized and eased longstanding alcohol restrictions. In June, both Colorado and Pennsylvania enacted laws that were described as the biggest changes to the industry since Prohibition was repealed. "I don't think there's any question that in the last 10 to 15 years, there's been quite an uptick in wanting to change many of these laws," said Steven Schmidt, senior vice president of public policy and communications at the National Alcohol Beverage Control Association. "A lot of it seems to be focused on providing more access around the country."

States Keep Some Regulatory Authority under Revised Toxic Substances Act

On June 22, 2016, President Obama signed into law the Frank R. Lautenberg Chemical Safety for the 21st Century Act, or H.R. 2576, which provides for a major overhaul of the 1976 Toxic Substances Control Act. The chief concern for states in the bi-partisan negotiations that led to the passage of H.R. 2576 was that the bill would preempt states' ability to regulate chemicals within their borders. While H.R. 2576 gives the EPA greater authority over chemical regulation, it still allows state regulation of the chemical industry.

Getting the Lead Out: Upgrading Infrastructure for Safe Water

In the wake of the water crisis in Flint, Michigan, cities, states and the federal government are taking a closer look at the status of water infrastructure in the U.S. and its ability to deliver healthy and safe drinking water to residents. A recent *USA Today* report analyzing data from the U.S. Environmental Protection Agency found that over the past four years, close to 2,000 water systems in all 50 states showed excessive levels of lead in water testing results.

Public Universities Increasingly Pursue Out-of-State Students

America's public state universities were established primarily to serve the residents of their respective states, but recent findings show that state institutions are increasingly appealing to out-of-state students.

Opponents of this practice have concerns that certain in-state applicants are being neglected and left behind. An analysis of 100 state universities, including the flagship institution of each state and one additional prominent public university, shows that from 2004 to 2014, 74 saw declines in in-state freshmen as a share of total enrollment.

Harris County began its recovery process, but the county quickly encountered difficulties with contractors regarding code review and safety standards.
