### Governor Nikki Haley News:

**Post and Courier:** Gas tax debate returns as roads remain a top priority in 2016

The old saying money can't buy happiness is especially true when it comes to fixing South Carolina's aging and crumbling roads and bridges. Lawmakers will have an additional \$1.2 billion in new revenue and unspent cash available when they return in January for the second round of a two-year legislative session.

**Note:** A roads bill was derailed last session by a feud that erupted between Haley and the new leader of the Senate, Hugh Leatherman, R-Florence.

**Note:** Haley unveiled her promised transportation plan in her State of the State address, threatening to veto any hike in the gas tax that wasn't offset by a hefty cut in the state's income tax. That conflicted with proposals lawmakers had worked out, raising the gas tax, but leaving the income tax unchanged.

**Note:** With neither side backing down, Haley called out lawmakers in their hometowns, causing some to speculate that Leatherman bottled up ethics reform — one of Haley's priorities — in retaliation for her opposition to lawmakers' roads bills.

**Note:** Haley's spokeswoman, Chaney Adams, said the governor is standing by her request for a 2 percent decrease in the state income tax if the gas tax is raised. "The governor has been clear about her plan to invest in roads and bridges, and that hasn't changed," Adams said.

The high court's decision in the 22-year Abbeville lawsuit found that students in mostly minority, impoverished rural school districts had not been receiving a minimally adequate education as guaranteed by the state constitution and ordered the Legislature to come up with a plan to rectify that.

**Note:** Soon after the court issued its split 3-2 decision in November 2014, Gov. Nikki Haley and House and Senate leaders challenged it, questioning whether the justices even had to order the Legislature to take action and asking that the ruling be reconsidered.

**Note:** Haley and legislative leaders argued that the court had not given the state credit for recent steps to improve education or been specific about what it expected lawmakers to do.
