Dear Mr. Patrick Maley: Please accept this correspondence as an official request to re-open my initial case filed with your office under the acting leadership of Mr. Jim Martin. Please be advised, all of South Carolina Law Enforcement Divisions {SLED} false, trumped up, bogus and discriminatory arson charges were dismissed without a trial.

Four plus years being held on Bogus trumped up felony charges. This racist discriminatory action was executed in an effort to silence a veteran Officer for reporting sexual misconduct within the Richland County Sheriff's office. Brief Chronology of events, Rented home intentionally set on fire two times in one week. Arrested by SLED on alleged arson charges 90 days later without probable cause. Owner of rented home former police officer collected insurance proceeds from two previous fires totaling 1/2 million dollars. Despite concrete evidence, SLED refuse to pursue him. Placed on \$150,000 bond, falsely incarcerated for 22 months. Needless to say, all charges were dropped and expunged from my official alleged criminal history four years later. This is how black lives matter in Richland County, South Carolina!

Fraud, extortion, bribery, sexual assault, intimidation, coercion and deception appeared to have been their motive. African Americans have become the statistical plantation pawns for their institutional extortion. They have been systematically targeted by law Enforcement for political and financial gain. The intentional destruction of the African American families continue to be plagued by these ruthless cowards in Richland County, South Carolina. Their institutional racism and bribery pivots on the concept of deception within the African American community. No functional Check and balance system in place to alleviate these types of discriminatory practices.

Today, 98% of the individuals incarcerated at the County level are African American in Richland County. What

message is this sending to the youth of America? Caucasian individuals operate under a different set of rules and standards? The law does not apply to them?

It's a sad day in the State Of South Carolina when it's State Law Enforcement agency uses its' authority and personnel to discriminate against people of color. I trust this situation will be thoroughly investigated and that the Criminal involved will be brought to justice.

There are countless other victims of this type of harassment, misconduct and unethical behavior throughout Richland County and the State. African American business owners are systematically victimized by the underhandedness of law enforcement and governmental agencies. African American business owners are targeted and threatened, If they refuse to comply with the establishment's unwritten rules. Subtle forms of revenge/ intrusion are administered via local law enforcement, SLED and Judicial authorities. This is performed without probable cause, investigation or proper due process. Thus, African American businesses are place in jeopardy if one refuses to comply with their illegal request.

Institutional racism continues to hinder African American Businesses within this state for obvious political and financial reasons. This must come to an end, people of color should not have to endure systemic racism from state Government and law enforcement.

In closing, I'm requesting your organization conduct a through investigation into these matters and hand over it's findings to the federal authorities for review and investigation.
