Mathew Staver, chairman of Liberty Counsel, says the left is going after President Trump's Supreme Court nominee Brett Kavanaugh so viciously because they want their social policy advanced and it won't move legislatively.



The American Family Association, a socially conservative organization founded in 1977, immediately called on its members to rally against Kavanaugh. ["AFA to Supporters: Tell Senate to Oppose SCOTUS Pick Brett Kavanaugh."](#)

In the release, AFA President Tim Wildmon said:

"Judge Kavanaugh's reasoning on religious liberty, Obamacare and issues concerning life have proven to be of major concern. For these and other reasons, we are calling on citizens to urge their senators to firmly oppose the nomination of Brett Kavanaugh as a Justice on the United States Supreme Court."

Reportedly, another organization, March for Life, had concerns about Kavanaugh that its leadership shared with Vice President Mike Pence, [arguing that the judge lacked the "backbone"](#) to overturn Roe.

Other social conservatives were sounding the alert about Kavanaugh days before the pick was made.

Joy Pullmann, managing editor of the Federalist, wrote a piece published July 6 titled ["Trump Loses My Vote If He Nominates A Justice Weak On Religious Liberty,"](#) but the URL was less circumspect, reading, "trump-would-lose-my-vote-if-he-nominates-brett-kavanaugh-over-amy-coney-barrett."

Kavanaugh will need 51 votes to clear the Senate. The big worry has been whether Sens. Lisa Murkowski (R-AK) and Susan Collins (R-ME) would support him (or any pick) if they deem the pick too extreme on reproductive health.

But now, there could be another issue for Republicans. [If the social conservatives build a successful pressure campaign, senators on the right might be uncertain votes, too.](#)

### Kavanaugh's case history

The issue with Kavanaugh among social conservatives centers on three cases in his judicial history at the Court of Appeals for the District of Columbia. In one case, *Seven-Sky v. Holder*, Kavanaugh's dissent sparked the concern.

## Kavanaugh: Good on Religion, Moderate Abortion, Bad Obamacare

I've just read two EXCELLENT articles about Justice nominee Kavanaugh, (one praising him, one criticizing him) by my friends Steve Ertelt [here](#) and Phillip Jauregui [here](#).

On Abortion and Obamacare, Kavanaugh moderately opposed conservative positions. On Religious Freedom, Kavanaugh defended Christians and free speech.

**On Abortion** in the Garza case, Kavanaugh wrote: "in sum, under the Government's arguments in this case and the Supreme Court's precedents, the unlawful immigrant minor is assumed to have a right under precedent to an abortion."

While Kavanaugh properly dissented from allowing the government to facilitate an abortion of an illegal immigrant child, his quote above assumes that Roe v. Wade precedent grants a right to kill a child. If you believe this quote, Kavanaugh will not overturn Roe v. Wade.

**On Obamacare**, NBC News reports (below) about Kavanaugh: "At times, he has diverged from the Republican party's ideological line on important cases that have come before him, including on the Affordable Care Act, the 2010 health care law which Kavanaugh has declined to strike down on a number of occasions in which it has come before him."

Specifically in NFIB vs. Sebellius, Kavanaugh referred to an Obamacare "tax penalty" which was not called a tax in Congressional statute but Justice Roberts later assumed Kavanaugh's words and turned Obamacare into a tax, making it legal. Kavanaugh's tax language saved Obamacare, like Roberts, and unlike Justice Scalia who wanted it struck.

**On Religious Freedom and Free Speech**, Kavanaugh defended Priest for Life who sought to opt-out of the Abortion mandate of Obamacare on religious grounds, and promoted freedom for Christians to buy advertising on the DC Metro.

"The Washington Metropolitan Area Transit Authority (i.e., the Metro) bans 'issue-oriented advertising,' which it interprets to include religious ads. So when the Catholic Archdiocese of Washington wanted to run an ad with the words 'Find the Perfect Gift' and an image of shepherds following a star in the sky during the Christmas season, Metro vetoed the ad. The archdiocese sued Metro for violating the First Amendment speech and religion

clauses, as well as the Religious Freedom Restoration Act. The district court ruled for Metro, and the archdiocese appealed to the D.C. Circuit, where the oral argument pitted Paul Clement (representing the archdiocese), a solicitor general in the George W. Bush administration, against Donald Verrilli (representing the Metro), a solicitor general under Obama. Kavanaugh hammered Verrilli with what the Washington Post called 'unrelenting' questioning about the Christmas-ad ban, which the judge described as 'pure discrimination' and 'odious to the Constitution,'" [reports](#) LifeNews.

**Bottom line:** Kavanaugh will be good on religious freedom, but has waffled on issues like Abortion and Obamacare.

He will not overturn Roe, but he will protect our liberty.

The internal White House debate over who should replace Justice Anthony Kennedy on the Supreme Court reflects the broader political split within the Republican Party - and the mistrust that is nursed by outside-the-Beltway social conservatives about the more establishment and business-oriented wing of the party.

So it is perhaps no surprise that a quintessentially Washingtonian fight has erupted between the supporters of the two leading candidates for the Supreme Court nomination, Judge Brett Kavanaugh and Judge Amy Coney Barrett.

While Barrett's supporters portray **Kavanaugh as insufficiently conservative**, Kavanaugh's supporters portray Barrett as insufficiently experienced - a judge whose conservative credentials are not yet clear in her opinions.

While [ [CLL: ecumenical](#) ] social conservatives have repeatedly thanked Trump for the [ [CLL: Jesuit-educated](#) ] Gorsuch nomination, they seem to want more. In an open letter last week, leaders of the American Family Association, the American Principles Project and other [ [CLL: ecumenical](#) ] socially conservative groups urged the appointment of Barrett.

"It is better to have a vacancy until next year than to fill the seat with a weak nominee **who will betray your legacy and the constitution** for the next 40 years," they wrote.

While nobody is saying that the president has really and finally made up his mind, **those opposed to Kavanaugh** are running out of time to gin up a real **opposition within the conservative movement**.

Of course, there is always the possibility that knocking out Kavanaugh would not mean knocking in Barrett. It might also mean that another one of the below judges gets the nod, including [Judge Raymond Kethledge of the 6th Circuit Court of Appeals in Michigan](#). The president met with Kethledge and reportedly got along with him.

In her academic writing, she has written somewhat dismissively of the doctrine of respecting the Supreme Court's precedents - a doctrine known as stare decisis. "There is little reason to think that reversals [of past decisions] would do much damage" to the court's reputation, she wrote. "I tend to agree with those who say that a justice's duty is to the Constitution" rather than to a precedent she thinks is clearly in conflict with it.

[ CLL comment: This is exactly right. Fidelity to the WRITTEN TEXT of the US Constitution is primary and superior to stare decisis. Stare decisis is used as a convenient tool by those who wish to perpetuate child-murder by "abortion". Consider the **1986 Bowers v. Hardwick** case, the US Supreme Court rightly upheld the Georgia statute criminalizing acts of sodomy; but then wrongly overturned Bowers v. Hardwick, overturning the Texas statute criminalizing sodomy in the **2003 Lawrence v. Texas** case ( Majority Opinion written by **Reagan** - appointee Anthony Kennedy ), **ONLY 17 YEARS LATER !!!** ]

Such comments are likely to raise a red flag to Republican senators like Susan Collins of Maine, who have said they would not vote for a nominee who has expressed doubts about stare decisis when it comes to abortion and other long-standing Supreme Court decisions.

3. **William Pryor:** The Partisan (Right of Alito, Left of Clarence Thomas) Pryor is on the 11th Circuit Court of Appeals in Atlanta and he is the oldest of the possible choices. At 54, he would still have a long career ahead of him on the bench, however. He is by far the most outspoken of the three and the definitely the least liked by the Democrats. Choosing Pryor would fit the mold of Trump not caring what anyone says, but the President would be in for a fight to get him confirmed. He's probably not a Scalia-in-waiting, but who is? He's more in the mold of an Alito, but this all may be moot if the reports are correct, as it looks like he's probably on the outside looking in.

2. **Thomas Hardiman:** The Centrist (**Left of Roberts** , Right of Kennedy) Hardiman is definitely the more moderate of the choices, something conservatives are wary of after appointments like Kennedy and Roberts haven't turned out the way they had hoped for. He is the only one of the candidates or sitting members of the bench without an Ivy League pedigree. He grew up in public schools in a blue collar family and **went to [ CLL: Roman Catholic ] Notre Dame and put himself through law school at [ CLL: Roman Catholic JESUIT ] Georgetown** by driving a taxi. He fits the bill with regard to his pro-life stance and he is strong on the second amendment, but he is seen as a government friendly conservative like William Rehnquist and has sided with Big Brother on censorship issues. He is 51 and like the other two candidates would likely have influence for decades to come. He might be the most confirmable of the three, having been confirmed 95-0 on the appellate court with votes from Senate Minority Leader Chuck Schumer and Diane Feinstein. "Washington, DC and much of the nation was sent into an uproar on Wednesday after longtime Supreme Court Justice Anthony Kennedy announced he would soon retire after three decades on the bench," [reports](#) Business Insider.

"The question then became who President Donald Trump would nominate to succeed Kennedy, considering the court's swing vote on many recent decisions.

[18 months ago, William Pryor and Thomas Hardiman were second and third on the short list of 25 possible nominees, but President Trump selected Neil Gorsuch.]

"Trump said Kennedy's successor would be selected from his list of 25 candidates that he originally pitched during the presidential campaign. He already selected Supreme Court Justice Neil Gorsuch from that list when he was faced with replacing former Justice Antonin Scalia. Meanwhile, Senate Majority Leader Mitch McConnell said the Senate will vote on a Trump nominee this fall.

"When Gorsuch was selected, 3rd Circuit Court Judge Thomas Hardiman came in a close second. He may just have his turn this time around.

"Hardiman, 52, was voted onto the appeals court in 2007 by a 95-0 tally. Both Senate Minority Leader Chuck Schumer and Democratic Sen. Dianne Feinstein of California, the ranking member of the Senate Judiciary Committee, voted to approve him.

"Hardiman also has the backing of Trump's closest judicial source: his sister.

"Maryanne Trump Barry, a fellow 3rd Circuit judge, holds a high opinion of Hardiman. As an adviser who spoke with the president told Politico last year, "Maryanne is high on Hardiman."

3 Judges remain on Trumps SCOTUS short-list

President Trump has narrowed the list of potential nominees to the Supreme Court to three, and already favors one of them in his mind, but will announce Thursday.

"President Donald Trump has narrowed his first Supreme Court nomination to three finalists, with 10th Circuit judge Neil Gorsuch and 3rd Circuit judge Thomas Hardiman emerging as front-runners while 11th Circuit Judge Bill Pryor remains in the running but is fading, according to people familiar with the search process," [reports](#) Politico.

"Trump interviewed at least those three finalists in New York during the transition, according to a person familiar with the search.

Trump himself said Tuesday he would make a selection for the court's empty seat next week and summoned top Senate

leaders

to the White House to discuss his impending choice to replace Justice Antonin Scalia, who died nearly a year ago.

"The president wants to move as quickly as he can," said Leonard Leo, one of Trump's advisers on the court pick and a top official at the Federalist Society.

"Leo declined to discuss Trump's short list, but he praised both Gorsuch and Hardiman effusively.

"Under our Constitution, the power rests with the people, and that was at the core of Justice Scalia's legacy, and you heard from President Trump's inauguration that is the core of Trump's agenda, and that's very much the core of what Neil Gorsuch's record is as a jurist," Leo said. "He's an excellent writer. He's got sharp analytical ability, strong intellect and he's got a lot of strength and courage. Those are things that the president very much wants in a nominee."

Pryor was barely previously confirmed 53-47 by the Senate, but Hardiman and Gorsuch were both nearly unanimously confirmed.

4 questions Trump must ask Supreme Court nominee

I came across an insightful [column](#) by Nate Madden encouraging President Trump to carefully select a true conservative for the Supreme Court to replace Justice Scalia.

"Recent Marist polling found that 80 percent of Americans believe that appointing originalists to the highest bench in the land was either an 'immediate' or 'important' priority. Now, short lists are circulating and the Trump transition team is reportedly holding meetings with potential nominees...

"Here's what Trump's team (and eventually the Senate) ought to be asking candidates:

1. What are rights, and what does the Constitution have to do with them?

"One of the most visible consequences of the judicial oligarchy is a never-ending regime of ever-changing rights. Rather than being fundamental, transcendent, and bound up with our human dignity, 'rights' are now construed to mean whatever the state wants them to mean.

2. What does the 14th Amendment really do?

"The 14th Amendment was originally written with the intent of undoing the legal atrocities of chattel slavery.
