Molina Healthcare Establishing Operations In Charleston County *New Health Services Office Expected To Support 150 Jobs*

COLUMBIA, S.C. – Molina Healthcare, a managed care service provider with existing operations in 17 states, today hosted the grand opening of its new office facility in Charleston County. The new office at 4105 Faber Place Drive in North Charleston is expected to support 150 jobs in the area.

Molina Healthcare provides health services to financially vulnerable families and individuals covered by government programs, such as Medicaid and Medicare. The Long Beach, Calif.-based company was founded more than 30 years ago and presently offers health plans in 10 states, with South Carolina becoming the eleventh state. Molina Healthcare can begin offering health coverage to lower-income families and individuals in South Carolina starting January 1.

"We are excited to open our newest health plan in the great State of South Carolina," said Tom Lindquist, president of Molina Healthcare of South Carolina. "We are looking forward to working closely with the state's Health and Human Services, local providers and community organizations to provide high-quality care to our members here."

Additionally, Molina operates medical clinics in five states and offers health information management and business process outsourcing solutions through a subsidiary, Molina Medicaid Solutions (MMS) in five states.

"We welcome Molina Healthcare of South Carolina as a new health care provider in the state and commend their mission of serving those in our communities who need it most," said Gov. Nikki Haley. "We celebrate the creation of an additional 150 jobs in Charleston County."

Since January 2011, South Carolina has recruited more than \$1.1 billion in capital investment and 10,600 jobs in the service industry.

"South Carolina has shown that it's just right for businesses of all kinds, whether they're building high-performance automobiles or providing health care services," said Secretary of Commerce Bobby Hitt. "We welcome Molina Healthcare's operations to South Carolina as a means of enhancing our communities and
