**Subject:** Intervention Styles for Ministers and Pastoral Counselors

Bob,

Thank you for your offer to help fill seats in our upcoming cohort of "Intervention Styles for Ministers and Pastoral Counselors" with faith leaders from the African American community. It is our firm belief that the evidence-based practices we want to deliver will help these spiritual leaders serve their parishioners who present with substance use issues in a highly effective non-confrontational, person-centered and strength-based engagement.

It has always been one of FAVOR's tenants that there are many paths to recovery and all are cause for celebration. It is widely recognized that the majority of people of color nest their recoveries in the church. Our intent is to provide another highly-effective method of engaging individuals in the process of change.

Since our conversation yesterday, I have reached out to our training partners from the Morehouse School of Medicine, the Southeast Addiction Technology Center, where they responded with an offer of training resources that are highly-qualified and culturally congruent.

While we intend to keep to a 16-person cohort, we are probably going to seek a larger venue in Columbia that will provide more space for a larger training team, videography and observation.

We will offer this Cohort June 23-25, 2015. We would like to take you up on your offer to contact the church leaders to whom the Governor reached out, with an invitation to fill up to eight of the available seats. We want to elicit their input on the perceived value of the training for their ministries and to participate in a post-training advisory committee convened to inform us on ways we can refine our training to make it more culturally congruent. We would also ask participants to agree to consent to a brief survey at 30, 60 and 90 days post training.

We will provide this training free of cost. Additionally, we will provide lodging for all participant. This training is funded by the SAMHSA RCSP SN grant in partnership with the Southeast Addiction Technology Transfer Center, based in the Morehouse School of Medicine. On one evening of the three-day cohort, we would like to engage the cohort in a discussion/listening session designed to identify resources that would benefit recovery outcomes in their communities. We will also promote the idea of bringing peer coaches into their ministries.

We would like to document portions of the training and listening session which will be presented to our funders SAMHSA and Southeast ATTC.
