To All Republican Governors:

liberty, no justice, no safety, . . . So, now, I call upon you all, before it is too late for America, to come together for the good of our great nation's future & do the only thing possible to save our *jobs* *our* precious freedoms, our economy, our Judeo-Christian culture, our Constitution, our health, our entire way of life. It is time Republicans do an "end run" around the Dems. Tit for tat! Only, your end run will be legal. *Obama's haven't been.*

Thus, to prevent the U.S. from losing its sovereignty, & Americans from losing their freedoms, particularly those in our "Bill of Rights", I strongly urge you to use your Constitution-granted option to amend the U.S. Constitution by creating a "Bill of Responsibilities" to parallel the Bill of Rights.

There will eventually be responsibilities for citizens & all three branches of government. However, to try to get the whole list ready & ratified by the end of this summer, would be impossible. Right now the most important Responsibility involves the integrity of the elections. This must be defined in the first Responsibility with others being written in 2017 & even 2018.

I am not a Constitution scholar. There are plenty of them around, perhaps beginning with Hillsdale College which would be an excellent place to meet to write this amendment; then, with the Heritage Foundation, ^{or} even Constitutional scholars such as Clarence Thomas and Mark Levin. I will write what I think is crucial to be written, ratified, & applied to the upcoming 2016 election. Others can help you tweak it so it is legally written, *& fills any gaps.*

Thus: Bill of Responsibilities

Article I: CITIZENSHIP

A. Definition: "a citizen of the United States of America" shall be henceforth:

1. A person born of 2 U.S. citizen parents who each speak, read, & write English fluently, & who were educated in the U.S. school system at least 12 years.
2. Any person not having 2 U.S. citizens for genetic parents may become a naturalized citizen at age 18 or later by taking a sit-down test about America, written in English, about U.S. history, geography, & government (including our governmental documents). The test may not be taken on the Internet or the like. It shall be called the Test for Citizenship & given in multiple sites around the country, on the same day, at the same time—as is done for med boards, college entrance exams, etc. Noon EST, 11:00 CST, etc.
3. A person may not be a citizen of another country & be a citizen of the United States at the same time; foreign citizenship must be forfeited before becoming an American citizen.

4. A person convicted of a felony or treason will have his/her citizenship revoked until such a time as the sentence is completed & the then former felon can pass the Test of Citizenship to reinstate the rights & privileges of citizenship. Anyone convicted of treason, if allowed to live, permanently loses U.S. citizenship & all of its benefits, & the right to live in the United States or any of its territories. Any citizen, even a U.S. President, may be tried for treason.
5. No President or any other government employee, either elected or appointed, can confer citizenship on a non-citizen "by decree". Anyone receiving the privilege of citizenship in the U.S. must conform to the above *+ below* rules.
6. Any person who is on the path to citizenship & still learning English must supply his or her own interpreter or translator.
7. Any citizen involved in prescribing medical care must first offer natural, health restoring, cause-treating, not symptom-treating treatments before offering radiation, drug, or invasive treatments. (This should really be added to the Bill of Rights. Non-invasive before invasive tests & treatments, & natural before chemical, & no forcing of vaccines. This should be the right of every man, woman & child.)
8. Because the Quran requires the faithful to lie in support of it, allows them to lie for self-benefit, urges them to kill everyone who is not Islamic, who is gay, (& I don't know what else), **allows them to physically abuse their women & girls* they cannot become citizens until such time as they have a Reformation of the Quran & it becomes a ^(writings) book having laws that no longer violate the U.S. Constitution. Muslims who are currently U.S. citizens & are law-abiding, may continue to live in this country peacefully, but may NOT vote or be on any jury, may not hold any government, law enforcement, medical, or military position. *They may not be judges in any type U.S. court.*
9. Citizenship is not a God-given right. It is a privilege for law-abiding people.
10. *Marrying a U.S. citizen no longer confers citizenship on the spouse.*

B. Requirement: Every citizen will be issued an ID having a current (no older than 5 years) photo, & in some cases (such as those who have broken the law), also a fingerprint, as a visible part of the ID. This ID must be shown in order to get a job, get a driver's license, enroll in school, get medical treatment, get social security or any other government monies or equivalent, and to be able to vote in any U.S. election of the federal, state, or local level. (Muslim current citizens shall have their ID with a clear stamp, or clearly different border so to not be able to violate the above restrictions.)

C Elections:

1. There shall be NO ballots in the United States of America for any election, local, state, or federal, printed in any language other than English.
2. The current rules for absentee ballots (age, physical infirmity, being out of town at the election, perhaps proven to have extreme hardship in getting to the polls, or being in the military) apply. *The 1st application must be made in person its # being recorded by the clerk with a photo ID*
3. No election results shall be final until all ballots from out - of - the - country military personnel are counted & verified.
4. *The photo ID must be shown/verified in order to vote in any local, state, or federal election. ***

D. Business:

1. All business done by any company working in this country must be solely conducted, written, & done in English.
2. It is against U.S. law to sell U.S. land to any foreign person, country, or foreign-registered company, or other *business or religious* entity.
3. No manufacturing facilities on U.S. soil can be sold, as in 2 above.
4. (Possible exception): Foreign countries may have up to 2 acres of land on which their embassies or consulates are situated be considered their land.

E. Warning: (see bottom of next page)

So, the first type of Responsibility is Citizenship—of the individual if he/she wants to participate in American life on American soil;²⁾ of the people who operate our elections; and³⁾ of the businesses who operate in this country or with this country.

Article II in a Bill of Responsibilities could be Executive. This would delineate some pretty logical requirements for anyone seeking the office of the President, such as raising the minimum age; requiring a valid birth certificate before being put on the ballot (no waiting 2 years & then having ink eradications showing on it, for God's sake); having served at least 12 years (?20?) in state government before running for federal office; ("serving" would mean votine on $\frac{3}{4}$ of the legislation with a yes or no, not "present" or the like.); maybe having received an honorary discharge from having done military service; only medical records can be sealed; college records & writings cannot be sealed; has studied the Constitution & passed (!) You get the idea.

Article III would be the Legislative branch: raise the minimum age; term limits; etc. &, say, that they cannot pass any law that does not apply equally to them as to "us" including medical insurance! State experience before federal, etc., be required.

***5. There can be NO voting for President or Vice President of the U.S. on computers or other "machines". It must be done on a card or paper using a provided black marker to darken designated ovals.*

Article IV, the Judicial Branch: We can't have Supreme Court Justices who are too old or too young, who haven't ever even been lower court judges or tried cases before the Supreme Court. Justice Thomas would be a good one to spell out useful, fair criteria for this. But I digress. . . *They would be forbidden to use any foreign laws, including sharia law in any decisions* . . .

Because Congress has not done its job in protecting the Constitution & the American people (by controlling this President), you governors have to do it. Have you not all sworn to protect the Constitution? Do you not want the rule of law ^{again} in this country? Is this not to be a government of, by, & for the people of this country? Only if you get this amendment to our Constitution can America be saved. We want US sovereignty, not Globalism. Only by safeguarding our elections from illegal aliens (regardless of the euphemism the Dems use for them) can we have any chance of honest elections. Only if our elections are honest can we maintain a 2-party system. Only if we have a functioning 2-party system can we avoid the looming destruction of our economy, our medical care, our democracy & our self-government.

Article Five of the United States Constitution states that:

Altering the Constitution consists of proposing an amendment(s) and subsequent ratification. Amendments may be proposed either by the Congress with a 2/3 vote in both the House of Representatives and the Senate

or by a convention of states called for by 2/3 of the state legislatures. = 34

To become part of the Constitution, an amendment must be ratified by either—as determined by Congress—the legislatures of $\frac{3}{4}$ (three-fourths) of the states

or State ratifying conventions in $\frac{3}{4}$ (three-fourths) of the states.

Stack this with conservatives; they're rational, not emotional.

The vote of each state (to either ratify or reject a proposed amendment) carries equal weight, regardless of a state's population or length of time in the Union.

Deadline: The Constitution is silent on the issue of whether or not Congress may limit the length of time that the states have to ratify constitutional amendments sent for their consideration. It is also silent on the issue of whether or not Congress, once it has sent an amendment that includes a ratification deadline to the states for their consideration, can extend that deadline. . . . they can be put in the body of the amendment or in the joint resolution transmitting it to the states if Congress made the amendment. (This is for amendments proposed by Congress. I saw nothing about such if the states so propose.)
