Mr. Poore called the meeting to order and Reverend Joaquin Garrison gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to approve the minutes of April 28, 1977 Council meeting as mailed.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to readopt Emergency Ordinance Number 1.

On the motion of Mr. Bratcher, seconded by Mr. Rhodes, Council voted unanimously to adopt Ordinance Number 15 (Stuaffer Chemical Company) on third reading.

Mr. Angus E. Mitchell requested Council accept roads near White Street extension into the County system. Mr. Poore suggested Mr. Mitchell contact the County Engineer, Mr. Mac Walters.

Mr. Bob Pavey talked to Council concerning the Parents National Assurance Company. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to request Mr. Pavey work with Mr. Hehn to investigate our insurance needs and report back to Council on May 12, 1977.

Mrs. Cynthia Wood discussed the Legislative Delegation's budget request for the 1977-78 fsical year. Council accepted the Legislative Delegation's budget request as information.

Mr. Heyward Crider discussed the Tax Assessor's budget request for the 1977-78 fiscal year. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to request the County Attorney work with Mr. Crider to investigate the agreement between Smith Data Processing and Anderson County. Council accepted the Tax Assessor's budget request as information.

Mr. Poore discussed the Supervisor's Office, Stockade, Road Maintenance, Building Maintenance and County Farm's budget requests for the 1977-78 fiscal year. Council accepted all budget requests as information.

Mr. Hehn discussed the Purchasing Office's budget request for the 1977-78 fiscal year. Council accepted the Purchasing Office's budget request as information.

On the motion of Mr. Bratcher, seconded by Mr. Hooper, Council voted unanimously to allow Mrs. Campbell, whose name was not listed on the agenda, to appear before Council.

Mrs. Campbell requested Council pay for repairs to her which was damaged due to bad conditions of a County road. Mr. Poore assured Mrs. Campbell that there was nothing the Council could do.

On the motion of Mr. Rhodes, seconded by Mr. Bratcher, Council voted three (3) to two (2)

not to get involved in any way with the Civic Center feasibility study for twelve (12) months. Councilmen Fred Bratcher, Sam S. Gerrard and Daniel A. Rhodes voted for the motion. Councilmen Joseph G. Wright, III and David L. Hooper voted against motion.
