Mr. Poore called the meeting to order and Councilman David L. Hooper gave the invocation.

On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to approve the minutes from the April 6, 1982 meeting as mailed.

Mr. Wright asked to have the floor for personal privilege. Council heard Mr. Wright's remarks and several others talked.

Mr. Joe Farmer, representing Mr. Harry Whitehead, asked Council to permanently close an unused section of Cromer Road in Anderson County which lies immediately to the northwest of the government line for Hartwell Reservoir. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to close the section requested.

Mr. Trey Senn presented Resolution #150 and second reading of Ordinance #83 - Mitchell Manufacturing for One Million Dollars Industrial Revenue Bonds. Mr. Kenyon read them both. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted four in favor to adopt Resolution #150. Mr. Wright abstained. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted four in favor to approve Ordinance #83 on second reading. Mr. Wright abstained.

Ms. Gail Hunter with Bel-Path Cable TV asked for approval of Ordinance #77 on third and final reading. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to approve on third and final reading.

Mr. Watson presented budget transfers for the following:

On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to allow the transfers requested.

Mr. Watson presented sealed bids for the audit. The low bid-Mr. Chester Johnston for \$12,600 was discussed. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted 3 for and 2 against receiving the bids as information. Mr. Wright and Mr. Bratcher voted against the motion.


Mr. Kinley read Resolution #151 stated that Mr. Wright should be censured because the County Council considers it to be a conflict of interest for a member to also be a member of the law firm retained by Anderson County Council. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted three in favor, one opposed and one abstained, (Mr. Wright opposed & Mr. Bratcher abstained.) to approve Resolution #151.

Mr. Carver with the Concerned Citizens of Northern Anderson County, asked Council what action had been taken since the last time they appeared before County Council requesting a park. Mr. Poore stated that the County does not have the money to buy any land at this time. He also requested \$2500 for a study to be done on a sewer system for their area. Mr. Poore asked Mr. Carver to get with Mr. Senn with the Planning & Development Board and discuss the matter.

Mr. Poore heard from everyone that wished to speak.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to adjourn at 8:48 p.m.
