The statement about 3% of the senior population is based on the number of seniors served by our HCBS programs vs. the total population in the state. We currently serve approximately 28,000 seniors with a senior population of approximately 950,000. The number is low because we have limited funding for service. There are about 8,000 seniors on our waiting list. These are non-medicaid seniors.
