### What's at Stake for States? The Lines are Drawn in *Gobeille v. Liberty Mutual*

NASHP released a [new issue brief](#) on upcoming U.S. Supreme Court case *Gobeille v. Liberty Mutual*. The case, which the court will hear on December 2nd could limit states' ability to collect essential data to advance payment reforms, address cost and quality and assure consumers have information and access to care. At issue is whether or not a state can compel a self-insured employer to submit health care claims - data that shows how much was paid for health care services - to the state's all-payer claims data system (APCD). Eighteen states have enacted laws to create all-payer claims data systems and 20 more are considering doing so. See the full brief [here](#).

## [Request for Proposals](#)

The Connecting Criminal Justice with Health Care (CCJH) Initiative is currently soliciting responses to the [Request for Proposal due Friday, December 11 at 5PM ET](#). Facilitated by the Urban Institute and Manatt Health, with support from the U.S. Department of Justice's Bureau of Justice Assistance, this initiative targets the intersection of broad national debates about mass incarceration, the opiate epidemic, and the crisis in America's mental health system. Participating states and localities, chosen based a competitive process, will work with national experts to design, test, refine, and monitor solutions in three key areas: (1) Enrolling the justice-involved population into Medicaid; (2) Establishing systems of health care tailored to meet the distinctive needs of the justice-involved population; and (3) Creating sustainable financing mechanisms for health care provided to inmates in justice settings. Partnerships of state and local justice agencies, the state Medicaid program, and other stakeholders will come together through "Learning Collaboratives" to identify their highest priority problems, develop solutions, create performance measures, and adjust approaches during implementation.
