Mrs. Haley I'm asking you for a Governors pardon on the rest of my sentence, Add the 3 yrs to the 5 yrs probation I already have to do and please set me free, so that I can move on with what's left of my Life. I have an 18 yr. old ~~son~~ son who needs his dad for one, Two in 2013 my mom was diagnosed with Dementia and my dad needs me desperately to help him with not only my Mom, but their home and property. My parents are Very Good People and we Live in Conroe Texas, Just North of Houston TX. Towards Dallas.

Mrs. Haley I have alot of Medical problems,  
you are free to check on, SCDL Medical and  
MacDougall C.I. Medical Depts.

I've Learned a Large Lesson and have  
to live with the fact that someone did die in  
the Accident I was in, And I deal with that  
on a daily basis, and always will.

Mrs. Haley I hope you take my Appeal  
to you serious and help me. Some Contacts here  
in South Carolina that I know are the Two  
Different Attys. I've had on my case before,  
Attorney Tommy A. Thomas in Irmo, S.C., and  
Atty. Tricia Blanchette in Columbia S.C.. These  
Two people alone will tell you what Kind of  
person I Truly Am. I Believe you could also talk  
to the Associate Warden and or any part of the  
Security Staff at any of the 5 Institutions I've  
been at and you will find that I have been  
a very respectfull, Obedient Inmate, I have  
no write ups, no charges, no disiplinarys, I've  
never even had to do extra duty since I've been  
locked up, and that should say alot about How  
much I've Grown in the past 12 yrs.

Mrs Haley, In a Nutshell, I need to be home,  
I'm just taking up bed space in S.C.D.C.,  
and I'm sure the staff here would agree  
with me.

Mr. Haley please take my Plea For  
this Pardon personal and believe in me as so  
many others at home and even the people here  
I've mentioned. I would like you to even call  
my Dad in Conroe, Texas, 936-494-1341 and  
speak to him about me. My Dad will tell  
you the straight up facts about me, and even  
though he's my dad, he's an honest and good  
man in his 80's and very well respected in  
Texas.

Mrs. Haley I can't ask you enough to  
please take my plea for your help personal,  
contact the people I've listed, and please  
respond back to me as soon as possible, if  
you need more information, if there would be  
any way possible, I would like to speak to  
you in person or on the phone. Please Mrs. Haley,  
I can do 8 yrs. probation, just as easy as I can  
do 5 yrs. Please, take my plea to you personal  
and believe in me.
