Subject: Burglary to Dollar General Store

(Charleston County, SC) On September 4, 2016, shortly after 10:00 p.m., our deputies were dispatched to the Dollar General Store, 2344 Ashley River Road, to investigate a report of a burglary in progress. According to our deputies, two store employees were working when they heard what sounded like drilling on the roof of the store. The employees contacted the Charleston County Consolidated Dispatch Center and were advised to lock themselves inside the office until law enforcement arrived. The employees were able to provide dispatch the location of the suspect. When our deputies arrived on scene, the suspect was observed behind the counter going into the cash register. The suspect then ran to the back of the store and back up to the roof. Our deputies were able to contain the suspect by establishing a perimeter until additional units and a Charleston Police Department K9 Unit arrived on scene to assist in the apprehension. Without further incident, the suspect was called down from the roof by our deputies and taken into custody. The City of Charleston Fire Department also responded to the scene to provide assistance with getting up on the rooftop to clear it and collect evidence. The suspect, Michael Cannon Polensky, of Dogwood Road, was taken into custody and charge with burglary. A roll of coins worth \$10 were found on him during a search incident to an arrest. He was lodged in the Sheriff Al Cannon Detention Center.
