SECTION 1: The Minutes for the meeting of March 24, 2005; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving amendments to the 2005 STIP, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to advertise and select engineering firms to provide preliminary engineering services for the Andrews Bypass Phase II, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to advertise and select and negotiate with consulting firms to provide preliminary engineering services for the Greeleyville Bypass, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to advertise and select several consulting firms for the purpose of providing as needed photogrammetric services throughout the state, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to advertise and select a consulting firm for the purpose of providing engineering services to assist with the development of weigh station improvement projects statewide, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to advertise and select a consulting firm for the purpose of providing engineering services to assist the SCDOT with the development of the I-26/US1 project in Lexington County, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to secure the services of a consulting engineering firm to provide "on-call" pile driving analysis (PDA), as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 10: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway lettings of February 8, 2005 and March 8, 2005, as shown in detail in the Appendix.

SECTION 11: The Commission unanimously passed a motion approving the action of the Department concerning projects in the December, 14, 2004; January 11, 2005; February 8, 2005; February 28, 2005; March 8, 2005; and March 15, 2005 highway lettings, as shown in detail in the Appendix.

SECTION 12: Commissioner Carnell reported for the Finance Committee. Preliminary meetings have been held regarding the independent audit of the Department. Commissioner Carnell introduced Mr. Voight Shealy and Mr. Delbert Singleton of the Material Management Office, Procurement Services Division. Messrs. Shealy and Singleton reviewed the state procurement code requirements for the Commissioners.

A motion was made by Commissioner Truluck and seconded by Commissioner Harrell authorizing Commissioner Carnell and his committee to articulate the purpose of the independent review and include a list of items for review. The committee will bring this report to the full Commission for approval. The motion passed unanimously.

SECTION 13: Commissioner Harrell reported for the Legislative Committee and reported that items covered in the meeting included litter control and a presentation on the federal reauthorization bill. Commissioner Harrell also reported that the resolution thanking Miss South Carolina for volunteering her services to DOT on behalf of safety has been prepared and will be framed and presented to Anne Ashley Wood at a future meeting of the Commission.

SECTION 14: On motion of Commissioner Truluck, seconded by Commissioner Hardee, the Commission unanimously passed a motion approving the 2005 appropriation for the Harden Street in Richland County.

SECTION 15: On motion of Commissioner Truluck, seconded by Commissioner Harrell, the Commission unanimously passed a motion approving the 2005 appropriation of \$2.5 million for the Briggs DeLaine project.

SECTION 16: On motion of Commissioner Truluck, seconded by Commissioner Truluck, seconded by Commissioner Harrell, the Commission unanimously passed a motion authorizing the department to move ahead with the permitting for the Briggs DeLaine project with the understanding that right of way will not be purchased.

The Department requests Commission approval to advertise, select and negotiate with consulting firms to provide preliminary engineering services for the Andrews Bypass Phase II. The proposed multilane facility is Phase II of the Andrews Bypass on a new location that extends from the intersection of Andrews Bypass phase I and Truck Route SC 41 to US 521 west of Andrews. The work will include a development of an environmental document, obtaining permits, design, and plan preparation. The Department's workload prohibits the ability to maintain the proposed schedule. Therefore, consultant services will be needed.

REQUEST FOR PROFESSIONAL SERVICES

GREELEYVILLE BYPASS – WILLIAMSBURG COUNTY  
SIXTH CONGRESSIONAL DISTRICT/ COMMISSIONER TRULUCK

The Department requests Commission approval to advertise, select and negotiate with consulting firms to provide preliminary engineering services for the Greeleyville Bypass. The proposed multilane facility is a new location that extends from US 521 North West of Town of Greeleyville to US 521 East of Greeleyville. The Department does not have the equipment and qualified personnel to perform such services..

**Surplus Property Public Notice**

**April 21, 2005**

In accordance with the State of South Carolina Statue 57-5-340, by this publication the Department is making public the Surplus Property Real Estate Transactions to the State Highway Commission. The following sheets include a breakdown of surplus property real estate transactions. These transactions may have resulted from negotiations with property owners during right of way acquisition, direct sales, settlement of a condemnation action, and/or corrective actions to previously reported sales.

1. File 42.487 / Route I-26 / Spartanburg County / Fourth Congressional District

During construction of improvements on I-26, under File 42.487 in Spartanburg County, near the City of Spartanburg, the Department acquired right of way by Right of Way Easement from J. H. Bishop dated July 1, 1958.

A request was received from the adjacent owner's attorney asking the Department to sell a tract of right of way that was acquired for a road that was never built. The present owner is asking to buy the right of way that lies between his properties, in order to clear title for a development. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 2.6 acres of land to RCG of SC, LLC was executed on February 1, 2005, in consideration of \$26,500.00.

2. File 8.686 / Road S-37/482 Reloc. / Berkeley County / Sixth Congressional District

During construction of improvements on Roads S-37/482, under File 8.686 near Goose Creek in Berkeley County, the Department acquired the right of way for Road S-331 through the Construction Act dated March 19, 1959.

A request was received from the adjacent property owner asking the Department to convey a small section of abandoned Road S-331 (Berkeley Place). The request was circulated to the Engineering sections to determine if the small section of the old road could be declared surplus. After review, it was determined that the small section of the old road was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.06 of an acre of land to John Munzenmaier was executed on January 28, 2005, in consideration of \$7,700.00.

3. File 23.243A / Road S-136 / Greenville County / Fourth Congressional District

During construction of improvements on Road S-136, under File 23.243A in Greenville County, near the City of Greenville, the Department acquired right of way for Road S-136, by Condemnation from Edward Thomas Greer and James Phillip Greer dated August 24, 1998, and by Title to Real Estate from Palmetto Family Partnership, L. P. dated July 1, 1998.

The Department was contacted by the Greenville Hospital System requesting that a uniform right of way be established across their frontage, even if it meant that they would need to convey some new right of way to the Department. After review by the engineering sections, it was determined that a 50-foot right of way could be established through the hospital's property. This decision created a surplus of 0.52 of an acre of surplus right of way, and required 0.128 of an acre of land from the hospital. Since the acreage being conveyed exceeds the acreage received, the consideration of \$22,100.00 and exchange of properties was agreed to by both parties. Therefore, a Quitclaim Deed for approximately 0.52 of an acre of land to Greenville Hospital Systems was executed on February 1, 2005, in consideration of \$22,100.00.

4. File 39.746 / SC Route 8/135 / Pickens County / Third Congressional District

During construction of improvements on SC Route 8/135, under File 39.360 in Pickens County, in the City of Easley, the Department acquired right of way for SC Route 8, by Condemnation from Mr. J. F. Sherman dated October 9, 1958.

A request was received from the adjacent landowner asking the Department to relinquish a section of old abandoned SC Route 8. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.14 of an acre of land to George D. Cox, Jr. was executed February 1, 2005, in consideration of \$4,270.00.

5. File 23.394 / US Route 25 / Greenville County / Fourth Congressional District

During construction of improvements on US Route 25, under File 23.394 in Greenville County, near the City of Travelers Rest, the Department acquired right of way for US Route 25, by Title to Real Estate from Mrs. Helen Holiday dated September 28, 1956 and by Title to Real Estate from J. W. Watson, Jr. dated August 29, 1956.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant to sell. This very small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a Quitclaim Deed for approximately 0.05 of an acre of land to Furman University was executed on February 1, 2005, in consideration of \$300.00.

6. File 23.394 / US Route 25 / Greenville County / Fourth Congressional District

During construction of improvements on US Route 25, under File 23.394 in Greenville County, near the City of Travelers Rest, the Department acquired right of way for US Route 25, by Title to Real Estate from Mrs. Martha E. McClellan dated September 12, 1956.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant to sell. This very small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a Quitclaim Deed for approximately 0.12 of an acre of land to Furman University was executed on February 1, 2005, in consideration of \$700.00.

7. File 32.691 / SC Route 12 / Lexington County / Second Congressional District

During construction of improvements on SC Route 12, under File 32.546.3 in Lexington County, in the City of West Columbia, the Department acquired right of way for SC Route 12, from Lavern R. Norris, by Title to Real Estate dated August 27, 1973.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was listed with a real estate consultant. This very small uneconomic parcel of land with limited access was offered to the adjacent property owners with the Grantee making a request to purchase. Therefore, a quitclaim deed for approximately 0.13 of an acre land to James C. Courtney was executed on February 3, 2005, in consideration of \$2,000.00.

8. File 39.674 / SC Route 93 / Pickens County / Third Congressional District

During construction of improvements on SC Route 93 under File 39.674 in Pickens County, near the City of Clemson, the Department acquired right of way for US Route 123, from Barbara Gallaher, Michael Allison and Adrienne Allison Law, heirs to the Estate of Ila L. Forlidas, by Condemnation dated November 28, 2000.

A request was received from the adjacent property owner asking the Department to convey the remaining parcel of surplus property. The request was circulated to the Engineering sections to determine if the subject parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. A bid sale was held between all the adjacent owners because a Control of Access had rendered the property landlocked, with the Grantees making the highest acceptable offer. Therefore, a Quitclaim Deed for 0.493 of an acre of land to Harriette C. Bowen and Mary C. Harry was executed on January 20, 2005, in consideration of \$20,098.00.

9. File 39.398 / SC Route 123 / Pickens County / Third Congressional District

During construction of improvements on SC Route 123, under File 39.280 in Pickens County, near the City of Easley, the Department acquired right of way for SC Route 123, by Deed to Right of Way from Jack Oatis dated January 4, 1954.

A request was received from the adjacent property owner asking the Department to reduce the present 75-foot right of way of SC Route 123 to a 50-foot right of way line in front of his property. This action would unify the right of way that fronts the Grantee's parcel. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.13 of an acre of land to Walter L. Brooks was executed on January 20, 2005, in consideration of \$7,375.00.

10. File MSC 137 / Road S-105 / York County / Fifth Congressional District

The Department acquired land to construct a maintenance operations facility, MSC 137, in the Town of Hickory Grove, in York County, by Title to Real Estate from T. N. Edwards dated August 12, 1952.

This maintenance site was declared surplus by the Department and DEA Stan Bland. An appraisal was ordered and sent to the South Carolina Budget and Control Board, which approved the value and gave concurrence for this property to be sold. In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant. The property was marketed to the public with the Grantee making an offer above the appraised price. Therefore, a Quitclaim Deed for 8.036 acres of land to Grady B. Ramsey and Beth W. Ramsey was executed on February 3, 2005, in consideration of \$115,000.00.

11. File 40.255 / US Route 601 / Richland County / Second Congressional District

During construction of improvements on US Route 601, under File 40.255 in Richland County, near Wateree, South Carolina, the Department acquired right of way for US Route 601, by Title to Real Estate from John J. Bird and R. A. Huffstetler dated April 10, 1941.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant. The property was marketed to the public with the Grantee making an offer above the appraised price. Therefore, a Quitclaim Deed for approximately 8.25 acres of lowlands to Two Rivers Farms, LLC was executed on December 1, 2004, in consideration of \$15,000.00.

12. Road S-664 / Greenville County / Fourth Congressional District

The Department acquired right of way for Road S-664, River Street from the City of Greenville by Construction Act dated April 4, 1986, at no cost to the Department.

A request was received from the City of Greenville requesting that the Department transfer its rights in the abandoned right of way for Road S-664 to the City of Greenville. A portion of River Street has been relocated producing a small parcel of abandoned right of way. The city is making improvements for public use at this location. Therefore, a Gratis Quitclaim Deed for the City of Greenville was executed on February 24, 2005.

13. Road S-83 (Grove Creek Pkwy) / Greenville County / Fourth Congressional District

During construction of improvements on Road S-83, under File 23.286 in Greenville County, near the Town of Moonville, the Department acquired right of way for Road S-83, from Sue H. Earle by Deed to Right of Way dated April 27, 1948; from Bouseville Inc. by Deed to Right of Way dated May 1, 1948; and from Dr. C. B. Earle Estate by Deed to Right of Way dated May 3, 1948.

During negotiations to acquire right of way for Grove Creek Parkway, the Department agreed to convey portions of the Old Road S-83 in exchange for the new right of way needed. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Gratis Quitclaim Deed for approximately 2.70 acres of land to Greenville County Research and Technological Development Corporation was executed on February 24, 2005.

14. File 32.127B / US Route 178 / Lexington County / Second Congressional District

During construction of improvements on US Route 178, under Project 639A Reop in Lexington County, near the Town of Batesburg/Leesville, the Department acquired the adjacent parcel by Deed to Right of Way from S. J. Lewis dated September 30, 1930.

The Department's Legal Department received a request from the adjacent property owner asking the Department to convey a long narrow strip of right of way that was produced by the relocation of US Route 178. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. A Reverter Clause was added to the quitclaim deed should the Department need the property in the future. Therefore, a Gratis Quitclaim Deed for approximately 0.35 of an acre of land to Creek Ranch Holdings, LLC was executed on February 25, 2005.

15. File 26.139B / SC Route 31 / Horry County / First Congressional District

During construction of improvements on Southern Frontage Road, under File 26.139B in Horry County, near the City of Myrtle Beach, the Department acquired right of way for Southern Frontage Road, from Jonathan E. Formo by Title to Real Estate dated August 29, 2003.

During negotiations to settle a difficult condemnation case, the Department agreed to convey a small piece of adjacent surplus property as partial payment for the settlement. In exchange, the Grantee agreed to convey to the Department his surplus remainder adjacent to the Department's property. Therefore, a Gratis Quitclaim Deed for approximately 0.12 of an acre of land to Jimmy Paul Jordan, a/k/a Jimmy P. Jordan was executed on February 24, 2005.

16. File 1.527 / SC Route 28/72 / Abbeville County / Third Congressional District

During construction of improvements on SC Route 28, under File 1.288 in Abbeville County, near the City of Abbeville, the Department acquired right of way by Deed to Right of Way from S. M. Beaty dated December 12, 1955.

In order to eliminate encroachments by the landowner and by the Department, the parties have agreed to exchange properties. The property being exchanged will eliminate the need for an encroachment permit for the landowner and the need for the Department to acquire land for improvements at the intersection of SC Route 28 and SC Route 72. Therefore, a Gratis Quitclaim Deed for approximately 0.10 of an acre of land to P. M. Properties, Inc. was executed on March 1, 2005.

17. File 10.2001.2 / SC Route 41 / Charleston County / First Congressional District

During construction of improvements on SC Route 41, under Project 914 in Charleston County, near the Town of Mount Pleasant, the Department acquired right of way for SC Route 41, by Deed to Right of Way from August German dated June 1, 1938.

The project manager received a request from the adjacent property owner asking the Department to convey a parcel made surplus by the realignment of SC Route 41. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.22 of an acre of land to Ruth N. & Doyne M Love, II was executed on February 28, 2005, in consideration of \$5,800.00.

18. File 40.277 / Route I-77 / Richland County / Second Congressional District

During construction of improvements on Interstate Route I-77 under File 40.277A, right of way was acquired by the Department under File 40.789 in Richland County, in the City of Columbia by Title to Real Estate from Harriet Newman Burnside, Marion T. Burnside, Jr., and Harriet Ellen Burnside Richmond; and Harriet Newman Burnside, Marion T. Burnside, Jr., and Walter I May, as Trustees under the Will of Marion T. Burnside, Sr. by Title to Real Estate dated July 2, 1973.

In the Department's effort to liquidate property surplus to the Department, this parcel was listed with a real estate consultant. The property was marketed to the public with the Grantee making an offer above the appraised price. Therefore, a Quitclaim Deed for 2.22 acres of land to Cook Properties, LLC was executed on March 4, 2005, in consideration of \$55,000.00.

19. File 40.398 / Road S-361 / Richland County / Second Congressional District

During construction of improvements on Road S-361, under File 40.398 in Richland County, near the City of Columbia, the Department acquired right of way for Road S-361, by Letter of Dedication from the City of Columbia dated March 9, 1953.

Commissioner Hardee received a request from the City of Columbia asking the Department to convey Road S-361 to the city. The City plans to convey the property to Richland County School District 2 to assist with the Dreher High School project. The subject area was previously removed from the state's highway system by Commission action in November of 2004. This action would reduce the mileage to be maintained in Richland County. Therefore, a Gratis Quitclaim Deed for approximately 0.83 of an acre of land to the City of Columbia was executed on March 4, 2005.

1. File 32.127B / US Route 178 / Lexington County / Second Congressional District

During construction of improvements on SC Route 178, under File Project 639A Reop in Lexington County, near the Town of Pelion, the Department acquired right of way for US Route 178, by Deed to Right of Way from Peoples State Bank of SC dated October 16, 1930.

A request was received from the adjacent property owner asking the Department to convey a small piece of abandoned right of way in front of his property. This right of way was made surplus by the relocation of US Route 178. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. A Reverter Clause was added should the Department need to reacquire the property for any reason. Therefore, a Gratis Quitclaim Deed for approximately 0.50 of an acre of land to Ben Blackwell, Life Estate, John W. Gentry & Donna Sue Gentry Remainderman was executed on March 9, 2005.

2. File 10.841 / Road S-2057 / Charleston County / First Congressional District

During construction of improvements on Road S-2057, under File 10.841 in Charleston County, near the Town of Mount Pleasant, the Department acquired right of way for Road S-2057, by Right of Way Easement from Georgia-Pacific Investment Company dated January 26, 1977.

As part of the Park West Development in Mount Pleasant, the developer is going to realign Road S-2057 (Joe Rouse Road). The Town of Mount Pleasant has agreed to maintain the proposed new road and has asked the Department to abandon a small portion of the existing Road S-2057, which the Town has also agreed to take over the maintenance responsibility. The subject parcel was removed from the SCDOT's highway system by Commission action in January of this year. Therefore, a Gratis Quitclaim Deed for approximately 0.69 of an acre of land to the Town of Mount Pleasant was executed on March 9, 2005.

During construction of improvements on Road S-2573, under File 40.146A in Richland County, near Ballentine, South Carolina, the Department acquired right of way for Road S-2573 Spur, by Right of Way Easement from Eula M. O'Sheal dated June 22, 1981.

A request was received asking the Department to relinquish a 300-foot right of way spur back to the family from which it originated. Because this spur road is maintained by Richland County and the road provides access to other landowners, it was determined that the right of way should be deeded to Richland County when the section of Road S-2573 is removed from the state highway system with a commission action. Therefore, a Quitclaim Deed for approximately 0.05 of an acre of land to Infinger Furniture was executed on March 23, 2005, in consideration of \$8,750.00.

During construction of improvements on US Route 17, under File 26.449 in Horry County, near the City of North Myrtle Beach, the Department acquired right of way for an outfall ditch, by Ditch Right of Way Easement from Elva Willard Suggs dated November 27, 1967 and from Juanita West dated December 1, 1967.

The Department received a request from the adjacent property owner asking the Department to convey the existing ditch to them in order to construct improvements on the property. In exchange for the existing outfall ditch, the Grantee has agreed to convey an equal amount of land back to the Department and has further agreed to construct the new outfall ditch at their expense. The Department acquired land to construct a maintenance operations facility, MSC 169, near Van Wyck, South Carolina in Lancaster County, by Title to Real Estate from J. W. Crenshaw dated August 14, 1961.

This maintenance site was declared surplus by the Department and District Engineering Administrator of District 4, Stan Bland. An appraisal was ordered and sent to the South Carolina Budget and Control Board, which approved the value and gave concurrence for this property to be sold. In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant. The property was marketed to the public with the Grantee making an offer above the appraised price. Therefore, a Quitclaim Deed for 3.96 acres of land to Joseph D. Dillon and Kristina R. Dillon was executed on February 28, 2005, in consideration of \$100,000.00.



# State Statute- Section 57-3-40

- The Division of Mass Transit must develop and coordinate a general mass transit program and policy for the State in order to encourage the efficient development, implementation, operation, evaluation, and monitoring of mass transit systems, both public and private.
- All departments, boards, public authorities, or other agencies of the State or its political subdivisions, local government, transportation authorities, and other local public entities must cooperate with the department, provide assistance, data, and advice

# Proviso – 2004 Appropriations Act – Section 53.10

- The Department of Transportation shall continue to carry out and enhance the coordination planning and demonstration process for public transportation funding and resources
- The intent of this proviso is to improve access and delivery of transportation services, especially in rural areas. In planning and developing mechanisms for increasing coordination of funding streams and resources at both the state and local levels, the Department of Transportation shall work with each agency that provides funding for transportation and assure input in the process from major local providers of transportation services to the public, including current providers of coordinated public service.

# Federal Strategy “United We Ride”

- President George W. Bush released an Executive Order on Human Service Transportation Coordination in February 2004 to improve assistance to those who are transportation disadvantaged, by implementing coordination of transportation services to operate in the most cost and time efficient manner possible.
- The establishment of the Interagency Transportation Coordinating Council on Access and Mobility (CCAM), chaired by Secretary Norman Y. Mineta, US Department of Transportation, functions to facilitate access to effective transportation services within existing resources and simplify access to transportation for customers. CCAM includes leadership from 11 Federal Departments.
