AFFIDAVIT

Personally appeared before me, a magistrate of this county, one Detective M. Thompson, who, first being duly sworn, deposes and says that

**STEVEN WAYNE PARKER**

did within this County and State on the 16<sup>TH</sup> day of August, 2016, violate the criminal laws of the State of South Carolina in the following particulars:

**DESCRIPTION OF OFFENSE**

**BURGLARY 1<sup>ST</sup> DEGREE**

**16-11-311**

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on 8-16-16, at 4:18 am, while at 1259 Battle Ground Rd., Charleston SC, in the County and State aforesaid, the above named defendant, STEVEN WAYNE PARKER, did commit offense of violation section 16-11-311 of the South Carolina Code of Laws, 1976 as amended, **BURGLARY 1<sup>ST</sup> DEGREE**, in that he did willfully, unlawfully, and feloniously, enter the residence of the victim with the intent to commit a crime therein, to wit: Larceny.

That on the morning of 8-16-16 the victim, Karen Ann Nappo reported to the Charleston County Sheriff's Office that her home was entered by an unknown suspect while she was at home asleep. The victim awoke at 6:20 am to find that her i-pod, her purse and its contents had been stolen from her residence. According to the victim, Karen Nappo, she has a security system within her residence and upon viewing the video from the time period from when the incident occurred while she was asleep an unknown white male suspect was recorded on the inside of her residence while she was asleep. The unknown suspect is recorded entering her home, walking about her home and then leaving her home with her purse. According to the victim she does not know the unknown suspect and did not give him permission to be inside of her home.

Deputy A. Engler and Deputy D. Sansom responded to the victim's residence and received a still photo from her security system. That photograph was circulated through law Enforcement channels and Deputy Sansom eventually had contact with Charleston City Police Detective J. Harvil. Detective Harvil was able to positively identify the suspect as the defendant, Steven Wayne Parker. The photograph was also viewed by Charleston County Sheriff's Detective Z. Khan, he too was able to positively identify the suspect as the defendant, Steven Wayne Parker. Both Detective Khan and Detective Harvil stated that they have had investigative encounters with the defendant in the past where they both had separately arrested and had dealings with the defendant.

This information was revealed through the investigation of Det.M.Thompson of the Charleston County Sheriff's Office, and he along with the signed written statement of the victim, and the testimony provided by Detective Khan and Detective Harvil are all witnesses to prove the same against the form of the statute and the peace and dignity of the state.
