If we shifted to a differential fee (\$20/month for pipe smokers and \$50/month for cigarette smokers, for instance), would that cost us our grandfathered status? Thanks.

The House has adopted the conference report on the budget, and we expect the Senate will follow suit later today, putting the Governor on a 5-day clock to prepare and issue any budget vetoes.
