RESPONSE TO U.S.  
DEPARTMENT OF  
EDUCATION

The Commission approved the response to the U.S. Department of Education's evaluation of the 1982-83 Annual Report on Higher Education Desegregation Efforts in South Carolina.

CAPITAL  
IMPROVEMENTS

The Commission approved the following capital improvement requests: (1) Indoor Track Surface on Concourse Level of Littlejohn Coliseum, Clemson University, (2) Lease of Buildings at 300 Sumter Street and 700 College Street, USC-Columbia.

LICENSURE OF  
TOMLINSON COLLEGE

The Commission granted Tomlinson College, Cleveland, Tennessee, a regular (five-year) license to operate at the associate degree level in South Carolina, subject to renewal every five years.
