<MSG>My husband and I adopted triplet girls in 1998 classified as special needs by the CYS agency in Pennsylvania. They are covered for health insurance under Medicaid HMO. They are currently 11 yrs and attending a private Christian school. Last October, we had all three undergo psychological testing as suggested by their teacher and Rachel was diagnosed ADD and Rebecca was diagnosed with a LD. Rachel was prescribed Vyvanse by our pediatrician which had terrible side effects. She was extremely, extremely hostile and violent. He then prescribed Focalin XR. Since she has been taking these meds, she has attained A honor roll and is organized, focused and confident at school. The improvement is incredible. She has taken the meds for 7 months. January 1 the HMO denied the meds saying she had to "try" two other meds before it could be approved. The doctors office was told "that the focalin should never have been approved but it was a mistake". We feel that they should have!
to be accountable. If in the beginning it was denied, it would have no problem to try something else then. But since Rachel has been taking it for so long and it is successful, we do not feel she should be penalized for a mistake on their part. I appealed twice and was not successful. Our pediatrician prescribed the best meds for her based on her medical history. Why should a 11 yr girl be a guinea pig to save \$\$\$. This is an outrage to have the insurance company taking the place of our pediatrician. The therapeutic benefits are similar but not exact and the side effects are not known. Rachel is currently taking a generic allergy medicine so it is not the fact of using the generic that is upsetting. Rachel is in middle school with standardized testing scheduled in April. If the meds the insurance company want do not work with her, her mental health and school work could be detrimentally affected. This is not right!! We are at the point we will file another appeal!
1 SCDHHS in Columbia. Changes must be made. We cannot afford!
to pay
for the Focalin without insurance and I do not want to have our daughter who is succeeding at school and feeling so proud and responsible put through "trying" medicines to appease the insurance company. Our pharmacist even went as far as to suggest have scripts written for the two other meds but not taking them and then applying again for the focalin. We do not want to commit insurance fraud. This is an issue of Rachel's rights. She has a disability and should be able to get the treatment her doctor feels is the best for her. Please help us!!</MSG>
