Gov. Nikki Haley says a judge's ruling over the state prison system's treatment of mentally ill inmates deals with dated allegations and the state has "come a long way" since they surfaced in a 2005 lawsuit. Last week, in a ruling connected to the lawsuit, Circuit Judge Michael Baxley issued a 45-page order finding the prison system had repeatedly violated the rights of mentally ill inmates, who in some cases lost their lives. He gave the agency six months to develop a plan of improvements for its handling of such inmates.

Gov. Nikki Haley detailed her \$6.61 billion executive budget in Columbia on Monday, in what traditionally serves as an annual event to highlight the governor's fiscal priorities for the coming year. Haley said this is the third year she has proposed a balanced budget with a tax cut for South Carolinians, including small businesses.

Note: "This year's budget builds upon the themes that have been at the core of our priorities from the very beginning — creating jobs and improving the business climate, providing a better education for our children, making our state a safer place to live and work, strengthening our infrastructure without raising taxes, and protecting the most vulnerable members of our society," Haley said in a statement.

A metal stamping company is expanding its Fountain Inn facility in a move that will include a \$3.2 million investment and add at least 27 new positions "in the near future," Gov. Nikki Haley's office says. Stueken LLC, which provides precision deep draw and metal stamping components to the automotive, electronics and consumer goods markets, will expand its Fountain Inn location to address growing customer demand, according to the governor's office.

Note: "South Carolina is continuing to see existing companies expand and invest here, proving to the nation that this is the right place for manufacturing," Haley said. "I believe this will be an exciting year for South Carolina as our manufacturing sector continues to grow, and Stueken's creation of 27 new jobs in Fountain Inn is a great start."

Mattresses, a sofa and even a grill were among the items found during an expanded search for Heather Elvis. A few animal bone fragments and signs of an outdoor bonfire were also found in the woods near Dick

South Carolina House Speaker Bobby Harrell again Tuesday called on the attorney general to immediately release a state police review of ethics allegations against Harrell, saying he believes it will exonerate him. Harrell repeated his request in a news conference shortly before the opening of the 2014 legislative session. He said he believes the timing of Attorney General Alan Wilson's decision to send the case to the State Grand Jury on Monday was deliberate but that it won't affect his job as speaker.

When state legislators pack the State House Tuesday to begin the second session of the two-year General Assembly, the likely fodder for chatter will be S.C. Attorney General Alan Wilson's announcement Monday that he referred ethics allegations against House Speaker Bobby Harrell -- and a subsequent SLED inquiry and report -- to a state grand jury for further investigation. Harrell, a Charleston Republican and arguably one of the most powerful men in the state, has been under investigation by SLED since February, after Ashley Landess, president of the S.C. Policy Council, raised questions about whether Harrell used his campaign account and position unlawfully.

The S.C. Department of Revenue is working to move forward after the nation's largest data security breach at a state agency. More new schools may be coming to the county as the Horry County school board on Monday scrapped two unpopular plans to combat overcrowding in the Carolina Forest attendance area in favor of revisiting the short-term capital plan for the entire district. The board had considered two plans to ease overcrowding at Ocean Bay Middle School – a K-6 option that would have moved the sixth grade at Ocean Bay Middle to River Oaks, Carolina Forest and Ocean Bay elementary schools, and the district's original recommendation that would have shifted most students who attend Carolina Forest Elementary School to Black Water Middle School.

As of Tuesday, Myrtle Beach will not issue business licenses to sexually oriented businesses while the planning department researches whether changes need to be made to the city's zoning laws after changes were made in the county.
