Pursuant to Section 2-17-110(D), a lobbyist may not serve as a member of a state board or state commission. However, the "Aiken County Commission for Technical and Comprehensive Education" is most likely NOT a state commission. Pursuant to multiple AG Opinions, the county technical education commission is an administrative agency of the county, and as such, the lobbyist prohibition does not apply.

Therefore, a registered lobbyist may be appointed to the Aiken County Commission for Technical and Comprehensive Education. Note that numerous other prohibitions on activity would still apply to the lobbyist as found in Title 2, Chapter 17.
